Question 1: What is the estimated budget for this project?

The County was awarded a total of \$642,000 of state-only funding through Active Transportation Program to complete Preliminary Engineering, Right of

Way, and Construction.

Question 2: Given potential delivery delays and office closures due to the ongoing

pandemic, will the County consider electronic submissions in lieu of hard

copies?

No. Consultants must submit proposals according to the requirements stated

within the Request for Proposal.

Question 3: Will geotechnical studies be required to determine the soil conditions, or

will typical county standards for sidewalk width and base preparation be

acceptable without geotech investigations?

A Geotechnical Assessment will be anticipated for this project.

Ouestion 4: Will landscape and irrigation be required for areas behind sidewalk limits?

No.

Question 5: How many stakeholder collaboration meetings are anticipated are desired?

This is to be determine as the project progresses. This project requires approval from the Department of State Architect. The County understands that final design may impact different stakeholders (e.g. power pole removal/relocation, school parking lot reconfiguration, etc.). It is up to the Consultant to determine

the best methodology to address stakeholder input within design engineering.

Question 6: On the corner of 11th Street and Heffernan Avenue, there are currently

parking stalls on 11th Street and Heffernan Avenue outside the fenced

surface parking lot. Are those staying in place or being removed?

Consultant will need to coordinate with Heber Elementary School on final design.

Question 7:

What is the anticipated half width of Heffernan Avenue – Center line of roadway to back of walk?

Consultant will need to conduct surveys to identify the limit for the construction as part of the coordination with the County during the design.

Question 8:

Please provide clarification regarding the contact lists that will be provided by the county for collaboration and outreach to neighboring residents, Heber Elementary School students, parents and other target stakeholders, or whether the consultant will be responsible for creating a contact list from scratch. We understand that we will update whatever list the County provides, but would like to understand how much contact information the County already has from prior engagement with this community?

The County does not have a contact list for collaboration/outreach, see response to Question 5. Consultant should be prepared to coordinate design efforts primarily with the Heber Elementary School District, Imperial Irrigation District, and any other utility companies.
