ADDENDUM NO. 1

NOVEMBER 22, 2021

This *ADDENDUM* is hereby made part of the Contract Documents and specifications to the same extent as if originally included therein, and shall be signed by the Bidder and included with the proposal.

This addendum addresses changes to the current RFP.

Item No. 1: Item 3.f. is to be added within section VI, Proposal Content and Format,

to include the following:

"Demonstrate a thorough understanding of the Subdivision Map Act, the Professional Land Surveyors' Act, local ordinances, accepted land surveying principles, and relevant rules or codes governing the conduct of Professional Land Surveyors. Identify any continuing education seminars or courses, active involvement in professional associations or committees, etc., which may have contributed to said thorough understanding."

Item No. 2: Section VII, Proposal Evaluation, has been amended to include:

"The selection committee will only include persons duly licensed as a Professional Land Surveyor or a Registered Civil Engineer, or have 20+ years' experience working under the direct supervision of a Professional

Land Surveyor or Registered Civil Engineer."

Item No. 3: The proposal evaluation form within Exhibit A is erroneously titled "As

Needed, On Call, Architectural Services". Please note, the title should

read "On Call, As Needed, Surveying Services".

Item No. 4: The proposal evaluation form has been amended to include an additional

bullet under Section A "Understanding of the laws, rules, etc., governing the conduct of Professional Land Surveyors" with the weighted factor of

(0.15).

Item No. 5: The proposal evaluation form has been amended to update the weight

factor for Sections A and D as follows:

Section A: "Past three (3) years of relevant experience, key personnel,

staff" has been changed from (0.15) to (0.10).

Section D: "Familiarity and/or specific experience with Federal, State, and Local government projects" has been changed from (.20) to (.10) The amended proposal evaluation form is attached.

The Contractor is responsible for advising any and all subcontractors of this change. Each bidder must acknowledge receipt of this addendum in the noted space below and must be attached to the proposal.
