This *ADDENDUM* is hereby made part of the Contract Documents and specifications to the same extent as if originally included therein, and shall be signed by the Bidder and included with the proposal.

1. Question: Regarding the bid plans for the Aten Rd Class 1 Bicycle Path, does the FDR and AC overlay begin at station 10+65?

**Response:** Per Cross Sections on Sheet 03, Full Depth Replacement (FDR) and AC overlay begins at Station 1+00.

**2. Question:** What are the estimated Working Days?

**Response:** 100 Working Days

**3. Question:** What is the Engineers Estimate?

**Response:** \$850,000

**4. Question:** What is the estimated Start Date?

**Response:** To be determined.

**5. Question:** The bid bond in the project specifications is on a combined page with addendums and my surety is questioning if there is a clean single page bid bond form without the addendum portions on them. Please advise.

**Response:** See Revised Pages 54, 55, and 56 below.

**6. Question:** The asphalt material on line item #7 calls for a modified asphalt oil. Can superpave be used instead of the modified asphalt?

**Response:** Caltrans ½" Type A PG76-22M HMA per Caltrans Standard Specification Section 39 may be substituted for the specified Greenbook mix.

7. Question: Regarding construction note 11, "CONSTRUCT CONCRETE PAVEMENT SECTION: 9.5" PCC OVER 6" AB, PER CALTRANS HIGHWAY DESIGN MANUAL AND SPECIFICATIONS," how is the concrete pavement and aggregate base paid? There currently are no bid items for these.

Full compensation for furnishing all labor, materials, tools, equipment, and incidentals, and for doing all the work involved in furnishing and installing Class 2 Aggregate Base, complete in place, as shown on the Plans, as specified in these Special Provisions, and as directed by the Engineer shall be considered as included in the contract price paid per ton for "Class 2 Aggregate Base" and no separate or additional payment shall be considered therefor.

## 14. Revision to Posted Specifications:

## Replace Section 40-1.04 PAYMENT with the following:

Full compensation for furnishing all labor, materials, tools, equipment, and incidentals, and for doing all the work involved in furnishing and installing Jointed Plain Concrete Pavement, complete in place, as shown on the Plans, as specified in these Special Provisions, and as directed by the Engineer shall be considered as included in the contract price paid per cubic yard for "Jointed Plain Concrete Pavement" and no separate or additional payment shall be considered therefor.
