Question 1: Site Preparation including grass and dirt removal if done by us can it be spread

around site?

Response: Yes. It shall be spread on the area indicated by County employees.

Question 2: Can either Interlocking Tile or PIP (Poured in Place) rubberized safety

surfacing be utilized for this project's surfacing?

Response: Either Interlocking Tile or PIP (Poured in Place) will be acceptable for this

project. Bidders shall propose either Interlocking Tile or PIP based on time and costs. This shall include full compensation for furnishing all labor, materials.

Question 3: Shall we include city permits in our scope of work?

Response: No. Governing Agency for permits is Imperial County Planning &

Question 4: New Sidewalk amount is not accurate on the RFP sheet (listed 155 sf) while it's

Question 5: Soil, sub-base and concrete testing will be done by contractor?

Ouestion 6: Will our flush curb diagram sheet with a side view, and measurements we use

for all our projects suffice for the 'engineered' drawing for the concrete mow

curb?

Response: Yes. A curb diagram sheet with a side view and measurements will suffice for

the engineered drawings.

Question 7:	Confirming that County will remove all trees, stumps, or roots in the ground of the play area?
Response:	Yes. County will remove any trees, stumps, or roots interfering in the ground of play area.
Question 8:	Please clarify the playground equipment critical fall height?
Response:	The critical fall height shall be of a minimum of 8' that will require a softer/thicker surface protection system.
Question 9:	What is the tentative start date for this project?
Response:	Start date remains tentative upon award of project.
Question 10:	Will the County Review and consider using a value engineered product for the playground safety surfacing?
Response:	Yes. Per Project Manual, if bidder's recommendation requires a more stringent subgrade preparation (such as concrete subbase), the bid item shall include Bidder's recommendation of subgrade preparation.
