IV. New Business

A. Traffic concerns from Law Enforcement Agencies

Mr. Masad asked about the park in Palo Verde and asked who he could speak with about maintenance. Ms. Robles stated she wasn't sure about Palo Verde but that the Parks Division was being overseen by Carmen Zamora, and he could reach out to their office.

Sheriff's Department stated that they've been seeing more racing along county roads like McConnel Road, Keystone Road, and Huff Road near Wheeler Road. It is speculated that the reason for this road racing increase is due to these recent paving of these road sections.

Sheriff's Department also stated that the section of Menvielle Road from SR-98 to Maggio Road in Gateway presents constant traffic issues due to the ongoing construction development west in the area and the lack of proper temporary traffic control management. Mr. Olmedo stated that the county was planning on meeting with the developer to assess the situation.

Mr. Olmedo stated that there are plans for future intersection improvements on SR-86 at Pitzer Road in Heber. Such improvements are to be completed by a private developer. There is no set date for the construction activities since the plan is still being discussed and reviewed by Caltrans, IID and the county, but it is estimated that the construction activities will require a 1-week, full closure of SR-86 at this location.
