## ADDENDUM NO. 3

This *ADDENDUM* is hereby made part of the Contract Documents and specifications to the same extent as if originally included therein, and shall be signed by the Bidder and included with the proposal.

- 1. Bid opening date has been postponed until August 7, 2025 at 3:00 p.m.
- 2. REPLACE the Bid Item List on Page 2 of the Notice to Bidders of the project specifications with the revised Page 2 Bid Item List attached to this Addendum.
- 3. REPLACE the Bid Item List on Page 58 of the Division XIV Bid Proposal of the project specifications with the revised Bid Item List Page 58 attached to this Addendum.
- 4. REPLACE SECTION: <u>TIME AND MATERIAL ALLOCATION</u> (Page 18 Control of Work) with

The Contractor shall provide a rate schedule for all labor and equipment that may reasonably be anticipated for use during the project. Labor rates shall be consistent with those required by the prevailing wage rate requirements of the contract and shall reflect all benefits and employer costs. Once the labor and equipment rates have been approved by the engineer, they will become the basis for compensation for any Time and Material work requested by the County. The Contractor is advised, however, that there will be no compensation from the Time and Material Allocation unless the work has been authorized in writing by the engineer. Additionally, use of the Time and Material Allocation will be at the sole discretion of the County. All or any portion of the allocation amount may be deleted from the Contract. The Time and Material allocation for this project shall be \$100,000. This is the number to be used for the bid proposals schedule.

# 5. REPLACE SECTION 37-6.04 with (Page 51 Division V Surfacing and Pavements):

#### **PAYMENT**

Full compensation for furnishing all labor, materials, tools, equipment, and incidentals, and for doing all the work involved in furnish, prepare, clean, and seal all cracks, complete in place, as shown on the plans, as specified in these special provisions, and as directed by the Engineer shall be considered as included in the contract price paid per square yard of Crack Treatments, and no separate or additional payment shall be considered therefor. The square yardage is the area of entire paved road surface the crack treatments are to be placed.
