SPECIAL NOTICE NO. 1

The bidder's attention is directed to Section 5 entitled, "Control of Work" which requires that proposed subcontractors be listed in the bidder's proposal. Instead of listing only subcontractors for signal and lighting work as in the past, all subcontractors are now to be listed in the bid proposal for items of work or portions thereof to be subcontracted in excess of one-half of one percent of the total bid or \$10,000, whichever is greater.

In the case where a bidder claims an inadvertent clerical error in listing subcontractors, a notice of the claim must be submitted to the Director of Public Works in writing within two working days after the time of the bid opening, and copies sent to the subcontractors involved.

SPECIAL NOTICE NO. 2

- Temporary traffic control requirements have been revised. The bidder's attention is directed to sections 7-1.03, 7-1.04, and 12. Sections include method of payment and requirements to furnish, install, and maintain temporary traffic control.
- The "Proposal and Contract" book has been retitled and is now the "Bid" book.
- The "Notice to Contractors" has been retitled and is now the "Notice to Bidders."
- Construction Contract Notification Requirement to the Office of Federal Contract Compliance Programs. Refer to Section 3 entitled, "Contract Award and Execution," found under Special Provisions.

SPECIAL NOTICE NO. 3

Pursuant to the requirements of Senate Bill 854 and California Labor Code section 1725.5, all contractors and subcontractors that wish to engage in public work through a public works contract must first register with the Department of Industrial Relation and pay all applicable fees.

No contractor or subcontractor may be listed on a bid proposal for a public works project unless registered with the Department of Industrial Relations, pursuant to Labor Code section 1725.5 (with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)).

No contractor or subcontractor may be awarded a contract for public work on a public works project unless registered with the Department of Industrial Relations, pursuant to Labor Code section 1725.5

Sealed proposals will be received at the office of the Clerk of the Board of Supervisors at the County Administration Center located at 940 Main Street in El Centro, California 92243, until **2:00 p.m. on August 22, 2025** at which time they will be publicly opened and read at the above stated time and place, for construction in accordance with the specifications therefor, to which special reference is made, as follows:

HEBER TOWNSITE IMPROVEMENTS FOR VARIOUS ROADS – PHASE II PROJECT
County of Imperial Project No. 7135CAPP

The contractor shall possess a California contractor's license, Class A, at the time this contract is awarded. In all contracts subject to this part where federal funds are involved, no bid submitted shall be invalidated by the failure of the bidder to be licensed in accordance with the laws of the State of California. However, at the time the contract is awarded, the contractor shall be properly licensed in accordance with the laws of the State of California. The first payment for work or material under any contract shall not be made unless and until the Registrar of Contractors verifies to the agency that the records of the Contractors' State License Board indicate that the contractor was properly licensed at the time other contract was awarded. Any bidder or contractor not so licensed shall be subject to all legal penalties imposed by law, including, but not limited to, any appropriate disciplinary action by the Contractors' State License Board.

Bids are required for the entire work described herein. The contractor does not have the option to submit a bid proposal on only a portion of the following described work. The contractor must respond with a bid proposal for Bid.

Recommendation of selection to award Base Bid will be based on cost and budget availability at time of award. For purposes of determination of the lowest bid, Public Contract Code Section 20103.8 (a) will be used.

Only those firms who have purchased the bid documents and the required trade journals will be directly provided any addendums that may be issued for this project prior to the bid opening date. Every attempt will be made to post addendums on the above-mentioned Imperial County Public Works website as well.

This contract is subject to state contract nondiscrimination and compliance requirements pursuant to Government Code Section 12990.

Inquiries or questions based on alleged patent ambiguity of the plans, specifications, or estimate must be communicated as a bidder inquiry prior to bid opening. Any such inquiries or questions, submitted after bid opening, will not be treated as a bid protest.

Bid security shall accompany the bid in the form of a certified or cashier's check, or a Bid Bond for ten (10) percent of the maximum bid amount being proposed.

The successful bidder shall furnish a payment bond and a performance bond, both equal to 100% of the contract amount. The submission of a labor and materials bond (payment bond) is required on projects in excess of \$25,000.00.

Bidders are advised that, they may substitute securities in place retained funds withheld by County. Cal. Pub. Cont. Code Section 22300. Alternatively, an escrow agreement, in the form prescribed by the code, may be used by the bidder.

The County of Imperial hereby affirms and notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, sex, color, or national origin in consideration for an award.

Federal, State and local regulations and reporting requirements applicable to the proposed work must be complied with for this project.

No work shall be performed by contractor or subcontractors who are ineligible pursuant to Cal. Lab. Code 1777.1 and 1777.7.

Contractor and its subcontractors shall pay all workers employed on the project the rates determined by the Director of California Department of Industrial Relations (DIR).

These wages are also available from the California Department of Industrial Relations' Internet web site at <http://www.dir.ca.gov>. Future effective general prevailing wage rates, which have been predetermined and are on file with the California Department of Industrial Relations are referenced but not printed in the general prevailing wage rates.

Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the County in which the work is to be done has been determined by the Director of the California Department of Industrial Relations and are on file and available from the Clerk of the Board of Supervisors located at the County Administration Center, 940 Main Street, Suite 209, El Centro, CA 92243.

If there is a difference between the minimum wage rates predetermined by the Secretary of Labor and the general prevailing wage rates determined by the Director of the California Department of Industrial Relations for similar classifications of labor, the Contractor and subcontractors shall pay not less than the higher wage rate. The Department will not accept lower State wage rates not specifically included in the Federal minimum wage determinations. This includes "helper" (or other classifications based on hours of experience) or any other classification not appearing in the Federal wage determinations. Where Federal wage determinations do not contain the State wage rate determination otherwise available for use by the Contractor and subcontractors, the Contractor and subcontractors shall pay not less than the Federal minimum wage rate, which most closely approximates the duties of the employees in question.

The U.S. Department of Transportation (DOT) provides a toll-free "hotline" service to report bid rigging activities. Bid rigging activities can be reported Mondays through Fridays, between 8:00 a.m. and 5:00 p.m., Eastern time, telephone no. 1-800-424-9071. Anyone with knowledge of possible bid rigging, bidder collusion, or other fraudulent activities should use the "hotline" to report these activities. The "hotline" is part of the DOT's continuing effort to identify and investigate highway construction contract fraud and abuse and is operated under the direction of the DOT Inspector General. All information will be treated confidentially and caller anonymity will be respected.

Withdrawal of bids shall not be permitted for a period of seventy-five (75) days after the date set for the opening thereof.

Monies withheld by the owner to ensure performance under the contract may be released in accordance with Government Code Section 4590 and these contract documents.

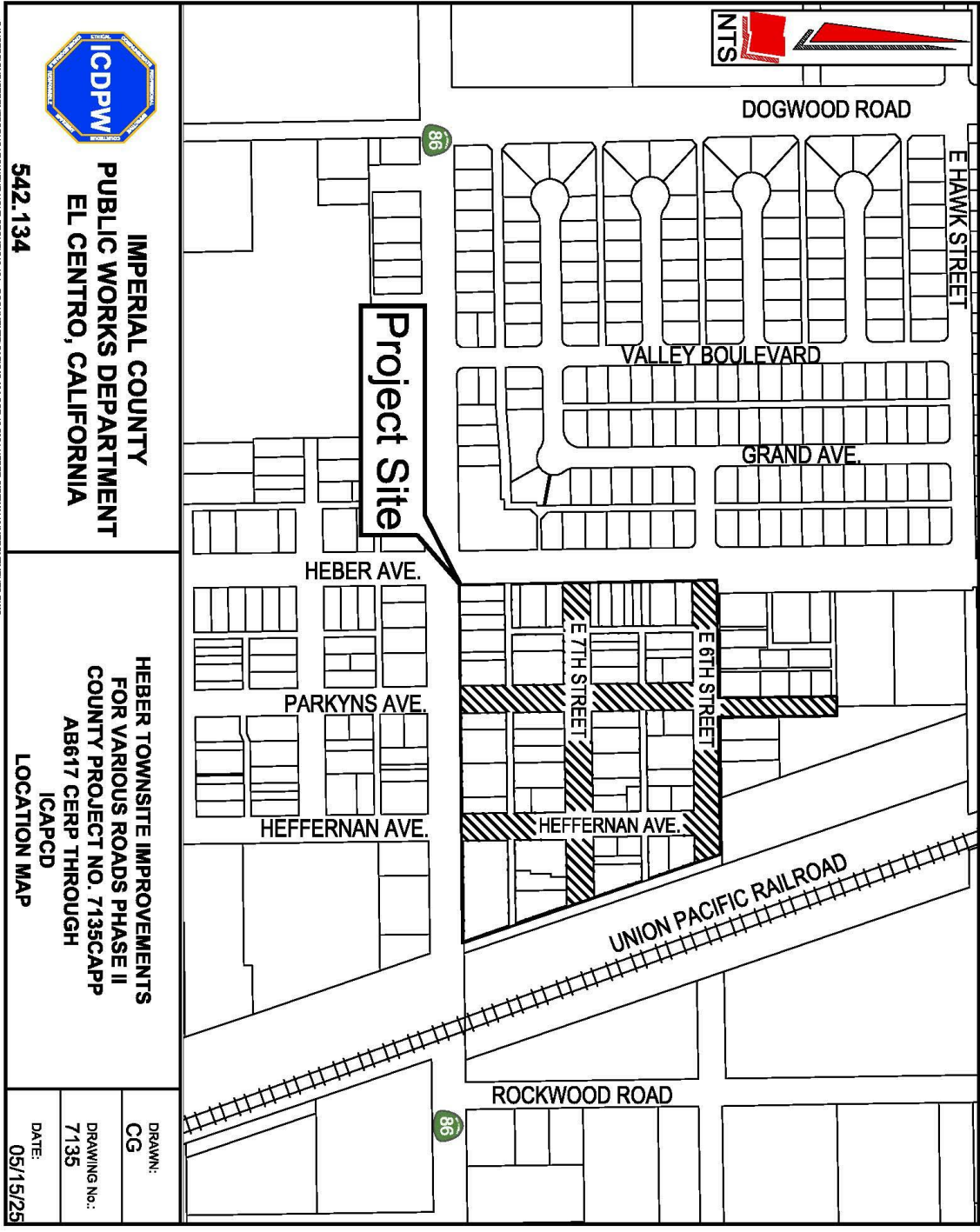

The party filing the protest must transmit a copy of all protest documents and any attachments to all other parties with a direct financial interest which may be adversely affected by the determination of the protest appeal concurrently.

The County will review the protest and make a determination.

The Notice to Proceed will be issued after the Contract has been approved by the Imperial County Board of Supervisors.

If the County awards the Contract, the award is made to the lowest responsible bidder within seventy-five (75) days. This period may be subject to extension for such further period as agreed upon in writing between the Department and you.

2. Unknown physical conditions of an unusual nature differing materially from those ordinarily encountered and generally recognized as included in the work provided for in the Contract are encountered at the site

Upon written notification the Engineer will investigate the conditions, and if the Engineer determines the conditions materially differ and cause an increase or decrease in the cost or item required for the performance of any work under the Contract, an adjustment, excluding loss of anticipated profits, will be made and the Contract modified. The Engineer will notify you of his determination whether or not and adjustment of the Contract is warranted.

You will be allowed 15 days from notification of determination to file a notice of potential claim as allowed under Section 5-1.43, otherwise the Engineer's determination will be deemed to have been accepted by you as correct.

Ensure the County's safe and unrestricted access to the work. Furnish facilities necessary for the County's inspection.

Where the means and methods to complete the work are not described in the Contract, choose the means and methods to complete the work.

Where the Contract describes more than 1 construction method or more than 1 type of material or equipment, the County does not assure that each construction method or type of material or equipment can be used successfully throughout all or any part of the project. You are responsible to use the alternative or alternatives that will accomplish the work under the conditions encountered.

Failure to comply with any Contract part is a waiver of your right to an adjustment of time and payment related to that part.

Use contract administration forms designated by the County.

Add "Time and Material Allocation":

The Contractor shall provide a rate schedule for all labor and equipment that may reasonably be anticipated for use during the project. Labor rates shall be consistent with those required by the prevailing wage rate requirements of the contract and shall reflect all benefits and employer costs. Once the labor and equipment rates have been approved by the engineer, they will become the basis for compensation for any Time and Material work requested by the County. The Contractor is advised, however, that there will be no compensation from the Time and Material Allocation unless the work has been authorized in writing by the engineer. Additionally, use of the Time and Material Allocation will be at the sole discretion of the County. All or any portion of the allocation amount may be deleted from the Contract. The Time and Material allocation for this project shall be **\$350,000**. This is the number to be used for the bid proposals schedule.

Upon request by the Engineer, immediately remove and not again use a subcontractor who fails to prosecute the work satisfactorily.

Payment for subcontracted work involved will be withheld from progress payments due, or to become due, until correction is made. Failure to comply may result in termination of the contract.

Noncompliance shall be corrected. Payment for subcontracted work involved will be withheld from progress payments due, or to become due, until correction is made. Failure to comply may result in termination of the contract.

Your subcontractors will perform the work and supply the materials they are listed for unless you have prior written authorization to perform the work with other forces or obtain the materials from other sources.

PROMPT PROGRESS PAYMENT TO SUBCONTRACTORS

A prime contractor or subcontractor shall pay to any subcontractor not later than 10 days of receipt of each progress payment in accordance with the provision in Section 7108.5 of the California Business and Professions Code concerning prompt payment to subcontractors. The 10 days is applicable unless a longer period is agreed to in writing. Any violation of Section 7108.5 shall subject the violating contractor or subcontractor to the penalties, sanctions and other remedies of that Section. Federal regulation (49 CFR 26.29) requires that any delay or postponement of payment over 30 days of receipt of each payment may take place only for good cause and with the agency's prior written approval. These requirements shall not be construed to limit or impair any contractual, administrative, or judicial remedies otherwise available to the prime contractor or subcontractor in the event of a dispute involving late payment, or nonpayment by the prime contractor, deficient subcontract performance, or noncompliance by a subcontractor. This provision applies to both DBE and non-DBE prime contractors and subcontractors.

The County shall hold retainage from the Contractor and shall make prompt and regular incremental acceptances of portions, as determined by the County of the Contract work and pay retainage to the Contractor based on these acceptances. The prime contractor or subcontractor shall return all monies withheld in retention from a subcontractor within 30 days after receiving payment for work satisfactorily completed and accepted including incremental acceptances of portions of the Contract work by the County. Federal regulation (49 CFR 26.29) requires that any delay or postponement of payment over 30 days may take place only for good cause and with the County's prior written approval. Any violation of this provision shall subject the violating prime contractor or subcontractor to the penalties, sanctions, and other remedies specified in Section 7108.5 of the California Business and Professions Code. These requirements shall not be construed to limit or impair any contractual, administrative, or judicial remedies otherwise available to the prime contractor or subcontractor in the event of a dispute involving late payment or non-payment by the prime contractor, deficient subcontract performance and/or noncompliance by a subcontractor. This provision applies to both DBE and non-DBE prime contractors and subcontractors.

PERFORMANCE OF SUBCONTRACTORS

The subcontractors listed by you in Bid book shall list therein the name and address of each subcontractor to whom the bidder proposes to subcontract portions of the work in an amount in excess of one-half of one percent of the total bid or \$10,000, whichever is greater, in accordance with the Subletting and Subcontracting Fair Practices Act, commencing with Section 4100 of the Public Contract Code. The

bidder's attention is invited to other provisions of the Act related to the imposition of penalties for a failure to observe its provisions by using unauthorized subcontractors or by making unauthorized substitutions.

The successful bidder and subcontractors agree to comply with Public Contract Code section 7103.5(b), which states: "In entering into a public works contract or a subcontract to supply goods, services, or materials pursuant to a public works contract, the contractor or subcontractor offers and agrees to assign to the awarding body all rights, title, and interest in and to all causes of action it may have under Section 4 of the Clayton Act (15 U.S.C. Sec. 15) or under the Cartwright Act (Chapter 2 (commencing with Section 16700) of Part 2 of Division 7 of the Business and Professions Code), arising from purchases of goods, services, or materials pursuant to the public works contract or the subcontract. This assignment shall be made and become effective at the time the awarding body tenders final payment to the contractor, without further acknowledgment by the parties."

PERMITS, LICENSES, AGREEMENTS, AND CERTIFICATIONS WITH OTHER ENTITIES

The Contractor shall coordinate with and be responsible for obtaining permission, permits and other documentation as necessary by any agencies and/or individuals that may be affected by the project in order to obtain any required authorization to access, construct, and permit to operate.

Full compensation for all coordination with and obtaining such permits and licenses shall be at contractor expense, including any agency permit fees. All items within the required permits shall be considered as included in the various items of work and no additional payment shall be made therefor.

Replace section 5-1.24 with:

CONSTRUCTION SURVEYS

The contractor shall use a person authorized to practice land surveying in the State of California.

Surveyor to verify both horizontal and vertical control and existing conditions. Surveyor to set local horizontal and vertical intervisible control on project site. Read and comprehend plans and resolve minor discrepancies, should any exist. Contractor shall preserve and, if necessary, surveyor shall perpetuate all existing horizontal and vertical monumentation.

Stakes and marks will be set by the surveyor sufficient to establish the lines and grades required for the completion of the work delineated on the plan set. The exact number of staking sets, horizontal location of construction stakes and associated grades required shall be decided at the pre-con meeting and may include any or all of the following: project limits, demolition limits, alignment, rough grade, final grade, slope stakes, face of curb, existing and proposed utilities and other staking as requested. Any cost to refresh and/or replace stakes is the sole responsibility of the Contractor. Cut sheets shall be provided to the County.

The Contractor shall provide a full set of field marked as-built plans including as in-field exclusions, revisions and/or changes to the original plan set.

Full compensation for providing Surveying work shall be considered as included in the contract lump sum price paid for "Surveying and Construction Staking" and no additional compensation shall be allowed therefor.

Replace the paragraphs of section 5-1.32 with:

AREAS FOR USE

Occupy County of Imperial Right-of-Way only for purposes necessary to perform the work.

If no County-owned area is designated for the Contractor's use, you may arrange for temporary storage with the County.

Personal vehicles of your employees must not be parked on the traveled way or shoulders, including sections closed to traffic.

Defend, indemnify, and hold the County harmless to the same extent as under Section 7-1.05 of the Standard Specifications.

The County does not allow temporary residences within the County of Imperial Right-of-Way.

Replace section 5-1.36C(3) with:

Nonhighway Facility Rearrangement

The County may rearrange a nonhighway facility during the Contract. Rearrangement of a nonhighway facility includes installation, relocation, alteration, or removal of the facility.

The County may authorize facility owners and their agents to enter the Right-of-Way to perform rearrangement work for their facilities or to make connections or repairs to their property. Coordinate activities to avoid delays.

Notify the Engineer at least 30 days before the interfering utilities are to be rearranged. The Engineer notifies the utility owners.

During the progress of the work under this Contract, the utility owner will relocate a utility shown in the following table within the corresponding number of working days shown. Notify the Engineer when the site is ready for utility work. After verifying the site is ready for utility work, the Engineer notifies the utility owner. The working days to relocate start on the notification date to the utility owner.

If necessary rearrangement of underground infrastructure is not described in the Contract, the Engineer may order you to perform the work. The rearrangement is change order work.

Immediately notify the Engineer of a delay due to a rearrangement different from that described in the Contract.

If you want infrastructure rearrangement different from that described in the Contract:

1. Notify the Engineer
2. Make an arrangement with the infrastructure owner
3. Obtain authorization for the rearrangement
4. Pay the infrastructure owner any additional cost

The County does not adjust time or payment for a rearrangement different from that described in the Contract.

Replace section 5-1.36D with:

MONUMENT PRESERVATION/PERPETUATION

The contractor shall be responsible for any survey monuments, corner accessories and/or benchmarks within the limits of work. In accordance with Professional Land Surveyors' Act (Chapter 15 of the California Business and Professions Code), such objects within the limits of work that may be disturbed or destroyed by construction shall be referenced by a person authorized to practice Land Surveying and a Corner Record (or Record of Survey) showing said references shall be filed with the County Surveyor prior to construction. Any monument, corner accessory, or benchmark that is disturbed or destroyed by construction shall be replaced with appropriate monumentation by a person authorized to practice Land Surveying and a Corner Record (or Record of Survey) shall be filed prior to project completion. Form MPR-01 and Form MPR-02 are required for all Imperial County Projects. See Division XVI "Exhibits & Permits" for forms.

It shall be the contractor's responsibility to complete a field survey to determine the existence of survey monuments, corner accessories, and/or benchmarks to be impacted prior to construction, said survey shall be conducted by a person authorized to practice land surveying. The field survey research shall include researching of survey monuments record/maps; completion of the field investigation to determine the existence/locations of the survey monuments prior to the commencement of construction activities for all roads impacted; placement of a flagged lath adjacent to the found monument indicating the direction and the distance of the monument from the lath; preparation of field notes for each found monument illustrating relative dimensions from the surrounding existing objects and the descriptions of the monuments; reporting to the County Surveyor/County of Imperial Public Works Department Director of the found monuments to evaluate the necessity to furnish a new survey monument for each found monument and to report the locations and the conditions of the found monuments; and all necessary field coordination with the Contractor to preserve/perpetuate the found monuments. The person authorized to practice land surveying shall complete a Pre-construction Monument Preservation Report (form MPR-01) and the report shall be provided to the Imperial County Surveyor prior to construction. The report shall be accompanied by necessary sketches, photos, or other records as provided in the Monument Preservation Report. In addition to said pre-construction Monument Preservation Report, if it is determined that survey monuments, corner accessories and/or benchmarks within the limits of work may be disturbed or destroyed, the person authorized to practice land surveying shall reference said items and file a corner record (or record of survey) of the references with the County Surveyor prior to construction.

Full compensation for completing necessary research, site inspection, field survey, report, and/or preparation of corner records (or records of survey) shall be considered as included in the contract lump sum price paid for "Monument Preservation/Perpetuation" and no additional compensation shall be allowed therefor.

Any existing survey monuments or County recognized benchmarks shall be protected by the Contractor. Should any such monuments or benchmarks be removed, damaged, obliterated or altered by the Contractor's operations, the Contractor shall be responsible for preservation or perpetuation by the proper resetting of the same as per the Subdivision Map Act, the Professional Land Surveyors Act and to the satisfaction of the County Surveyor/Director of Public Works Department. Such points shall be preserved or perpetuated with appropriate monumentation by a licensed land surveyor or a registered civil engineer authorized to practice land surveying.

All preserved or perpetuated survey monuments shall be protected by new ductile iron monument wells. The Contractor shall supply a new ductile iron monument well for each monument and horizontally position the monument well per the direction of the licensed land surveyor or registered civil engineer after the placement of the new pavement. The Contractor shall place a 12-inch wide, 12-inch deep P.C.C. concrete ring concentric with the exterior of the monument well per the County of Imperial Standards at the time the monument well is placed. Corner Records or a Record of Survey as appropriate shall be filed by the licensed land surveyor or registered civil engineer authorized to practice land surveying.

Prior to final project inspection, the Contractor is responsible to have a post-construction Monument Preservation Report (form MPR-02) completed by a person authorized to practice land surveying and submitted to the Resident Engineer for submittal to the County Land Surveyor.

If survey monument(s), corner accessory(ies), and/or benchmark(s) are disturbed or destroyed during construction, new monument(s), corner accessory(ies), and/or benchmark(s) shall be set in the surface of the new construction or a witness monument(s) set to perpetuate the original location of the disturbed monument(s) or benchmark(s). Contractor is responsible that a post-construction corner record(s) (or record of survey) be filed with the County Surveyor prior to final inspection of the project.

The Contractor shall be paid for preservation/perpetuation of survey monuments/benchmarks on a lump sum basis for all survey monument/benchmark to be preserved/perpetuated for all road locations encompassed in this project. The work associated with the preservation/perpetuation of the survey monuments/benchmarks shall include filing appropriate survey documentations/maps before and after the preservation/perpetuation of the survey monuments; jack hammering/sawcutting the new pavement surface to allow the installation of the new P.C.C. concrete ring and positioning of the monument well cover 3/8-inch below the new finish pavement surface; backfilling the monument well with compacted Class 2 Base; plumbing monument well; leveling monument well frames and covers; furnishing new brass disks with punching and marking for survey monuments, if necessary; preservation/perpetuation of survey monuments; installation of new P.C.C. concrete rings circumferentially around the monument well covers; removal and disposal of construction demolition material associated with the installation of survey monument wells and all other items incidental to preserving/perpetuating survey monuments in accordance with the Subdivision Map Act, the Professional Land Surveyors Act and to the satisfaction of the County Surveyor/Director of Public Works Department.

In the event that additional survey monuments/benchmarks are identified after the initial survey, they must be preserved/perpetuated with no additional compensation therefor.

Replace first and second paragraphs of section 5-1.47 with:

GUARANTEE

Guarantee all materials and equipment furnished and Work performed for a period of one (1) year from the date of Completion. You must warrant and guarantee for a period of one (1) year from the date of Completion of the project that the completed project is free from all defects due to faulty materials or workmanship and you will promptly make such corrections as may be necessary by reason of such defects including the repairs of any damage to other parts of the project resulting from such defects. The County will give notice of observed defects with reasonable promptness. Should you fail to make such repairs, adjustments, or other Work that may be made necessary by such defects, the County may do so and bill you. Your performance bond remains in effect through the guarantee period.

The guarantee excludes damage or displacement caused by an event outside your control, including:

1. Normal wear and tear
2. Improper operation
3. Insufficient maintenance

6-1.03B(2) Analytical Test Results

At least 15 days before placing local material, submit analytical test results for each local material obtained from a noncommercial source or a source not regulated under CA jurisdiction. The analytical test results must include:

1. Certification signed by an engineer who is registered as a civil engineer in the State or a professional geologist licensed as a professional geologist by the State stating:

The analytical testing described in the local material plan has been performed. I performed a statistical analysis of the test results using the US EPA's ProUCL software with the applicable 95 percent upper confidence limit. I certify that the material from the local material source is suitable for unrestricted use at the job site, it has a pH above 5.0, does not contain soluble lead in concentrations equal to or greater than 5mg/l as determined by the Waste Extraction Test (WET) Procedures, 22 CA Code of Regs § 66261.24(a)(2) App II, does not contain lead in concentrations above 80 mg/kg total lead, is free from all other contaminants identified in the local material plan, and will comply with the job site's basin plan and water quality objectives of the RWQCB.

2. Chain of custody of samples
3. Analytical results no older than 1 year
4. Statistical analysis of the data using US EPA's ProUCL software with a 95 percent upper confidence limit
5. Comparison of sample results to hazardous waste concentration thresholds and the RWQCB's basin plan requirements and water quality objectives for the job site location

The analytical test results must demonstrate that the local material:

4. Is free of possible contaminants identified in the local material plan
5. Complies with the RWQCB's basin plan for the job site location
6. Complies with the RWQCB's water quality objectives for the job site location

6-1.03C Local Material Management

Do not place local material until authorized.

If the Engineer determines the appearance, odor, or texture of any delivered local material suggests possible contamination, sample and analyze the material. The sampling and analysis is change order work unless (1) hazardous waste is discovered or (2) the analytical test results indicate the material does not comply with section 6-1.03B(3).

Dispose of noncompliant local material at an appropriately permitted CA Class I, CA Class II or CA Class III facility. You are the generator of noncompliant local material.

PUBLIC SAFETY

You are responsible to provide for public safety.

Do not construct a temporary facility that interferes with the safe passage of traffic.

Control dust resulting from the work, inside and outside the Right-of-Way.

Move workers, equipment, and materials without endangering traffic.

Whenever your activities create a condition hazardous to the public, furnish, erect and maintain those fences, temporary railing, barricades, lights, signs, and other devices and take any other necessary protective measures to prevent damage or injury to the public.

Any fences, temporary railing, barricades, lights, signs, or other devices furnished, erected and maintained by you are in addition to those for which payment is provided elsewhere in the specifications.

Provide flaggers whenever necessary to ensure that the public is given safe guidance through the work zone. Flagging must comply with section 12-1 of the Standard Specifications.

At locations where traffic is being routed through construction under one-way controls, move your equipment in compliance with the one-way controls unless otherwise ordered.

Use of signs, lights, flags, or other protective devices must comply with the current edition of the *California MUTCD* and any directions of the Engineer. Signs, lights, flags or other protective devices must not obscure the visibility of, nor conflict in intent, meaning, and function of either existing signs, lights and traffic control devices, or any construction area signs.

Keep existing traffic signals and highway lighting in operation. Other forces within the County will perform routine maintenance of these facilities during the work.

Cover signs that direct traffic to a closed area. Except for work specified in Section 12 of the Standard Specifications, maintaining, and removing the covers on construction area signs is change order work.

Install temporary illumination such that the illumination and the illumination equipment do not interfere with public safety. The installation of general roadway illumination does not relieve you from furnishing and maintaining any protective devices.

Equipment must enter and leave the highway via existing ramps and crossovers and must move in the direction of traffic. All movements of workers and construction equipment on or across lanes open to traffic must be performed in a manner that do not endanger the public. Your vehicles or other mobile equipment leaving an open traffic lane to enter the construction area must slow down gradually in advance of the location of the turnoff to give the traffic following an opportunity to slow down. When leaving a work area and entering a roadway carrying traffic, your vehicles and equipment must yield to traffic. Compensation for flaggers, used for all movement of workers and construction vehicles and equipment on or across lanes open to traffic, is included in the bid items of work involved. Immediately remove hauling spillage from a roadway lane or shoulder open to traffic. When hauling on roadways, trim loads and remove material from shelf areas to minimize spillage.

Notify the Engineer not less than 25 days and not more than 125 days before the anticipated start of an activity that will change the vertical or horizontal clearance available to traffic, including shoulders.

If vertical clearance is temporarily reduced to 15.5 feet or less, place low clearance warning signs in compliance with the current edition of the *California MUTCD* and any directions of the Engineer. Signs must comply with the dimensions, color, and legend requirements of the current edition of the *California MUTCD* and section 12-3.11 of the Standard Specifications except that the signs must have black letters and numbers on an orange retroreflective background. W12-2P signs must be illuminated so that the signs are clearly visible.

Pave or provide full width continuous and cleared wood walks for pedestrian openings through falsework. Protect pedestrians from falling objects and concrete-curing water. Extend overhead protection for pedestrians at least 4 feet beyond the edge of the bridge deck. Illuminate all pedestrian openings through falsework. Temporary pedestrian facilities must comply with the *California MUTCD*, Part 6, Chapter 6D, "Pedestrian and Worker Safety."

Do not store vehicles, material, or equipment in a way that:

1. Creates a hazard to the public
2. Obstructs traffic control devices

Do not install or place temporary facilities used to perform the work which interfere with the free and safe passage of traffic.

Temporary facilities that could be a hazard to public safety if improperly designed must comply with design requirements described in the Contract for those facilities or, if none are described, with standard design criteria or codes appropriate for the facility involved. Submit shop drawings and design calculations for the temporary facilities and show the standard design criteria or codes used. Shop drawings and supplemental calculations must be sealed and signed by an engineer who is registered as a civil engineer in the State.

If you appear to be neglectful or negligent in furnishing warning devices and taking protective measures, the Engineer may direct your attention to the existence of a hazard. You must furnish and install the necessary warning devices. If the Engineer points out the inadequacy of warning devices and protective measures, that action on the part of the Engineer does not relieve you from your responsibility for public safety or abrogate your obligation to furnish and pay for these devices and measures.

Install Type K temporary railing or other authorized protective systems under any of the following conditions:

1. Excavations: Where the near edge of the excavation is within 15 feet from the edge of an open traffic lane
2. Temporarily unprotected permanent obstacles: When the work includes the installation of a fixed obstacle together with a protective system, such as a sign structure together with protective railing, and you elect to install the obstacle before installing the protective system; or you, for your convenience and as authorized, remove a portion of an existing protective railing at an obstacle and do not replace such railing completely the same day
3. Storage areas: When material or equipment is stored within 15 feet of the edge of an open traffic lane and the storage is not otherwise prohibited by the Contract
4. Height differentials: When construction operations create a height differential greater than 0.15 feet within 15 feet of the edge of traffic lane

Installation of Type K temporary railing is not required if an excavation within 15 feet from the edge of an open traffic lane is protected by any of the following:

1. Steel plate or concrete covers of adequate thickness to prevent accidental entry by traffic or the public
2. Side slope where the downhill slope is 4:1 (horizontal:vertical) or less unless a naturally occurring condition
3. Barrier or railing

Offset the approach end of Type K temporary railing a minimum of 15 feet from the edge of an open traffic lane. Install the temporary railing on a skew toward the edge of the traffic lane of not more than 1 foot transversely to 10 feet longitudinally with respect to the edge of the traffic lane. If the 15-foot minimum offset cannot be achieved, the temporary railing must be installed on the 10 to 1 skew to obtain the maximum available offset between the approach end of the railing and the edge of the traffic lane, and an array of temporary crash cushion modules must be installed at the approach end of the temporary railing.

Secure Type K temporary railing in place before starting work for which the temporary railing is required.

If a traffic lane is closed with channelizers for excavation work, move the devices to the adjacent edge of the traveled way when not excavating. Space the devices as specified for the closure.

Do not move or temporarily suspend anything over a traffic lane open to the public unless the public is protected.

Full compensation for conforming to the provisions in this section "Public Safety," including furnishing and installing temporary railing (Type K) and temporary crash cushion modules, shall be considered as included in the contract prices paid for the various items of work and no additional compensation will be allowed therefor.

INDEMNIFICATION

You must indemnify and hold harmless the County, its agents, officers, and employees, against and from any and all claims, lawsuits, actions, liability, damages, losses, expenses, costs, and actual attorney's fees, arising out of or in connection with your performance of this Contract for (1) injuries to or death of any person or persons, including your employees, and (2) injuries to or destruction of property, including the loss of use, provided that any such claim, lawsuit, action, liability, damage, loss, expense, or cost is caused in whole or in part by any negligent or intentional act or omission from you, your subcontractor, anyone directly or indirectly employed by you, or anyone for whose acts any of them may be liable, regardless of whether or not it is caused by the passive negligence of a party indemnified hereunder.

For purposes of your obligation to defend, indemnify, and save harmless, the term State means (1) the County of Imperial, and (2) The Holt Group, Inc., including their officers, directors, employees, agents, and design professionals.

Your obligations under section 7 will survive the termination of the agreement.

7-1.06 INSURANCE

7-1.06A General

Nothing in the Contract is intended to establish a standard of care owed to any member of the public or to extend to the public the status of a third-party beneficiary for any of these insurance specifications.

You shall carry Public Liability and Property Damage Liability Insurance as well as Automobile Liability Insurance at all times when work is being performed. Before beginning work, provide the Engineer a Certificate of Insurance detailing the insurance amounts, to be reviewed and approved by the County.

7-1.06B Liability Insurance

7-1.06B(1) General

Carry General Liability and Umbrella or Excess Liability Insurance covering all operations by or on behalf of you providing insurance for bodily injury liability and property damage liability for the following limits and including coverage for:

1. Premises, operations and mobile equipment
2. Products and completed operations
3. Broad form property damage (including completed operations)
4. Explosion, collapse, and underground hazards
5. Personal injury
6. Contractual liability

Obtain insurance and submit all certificates of insurance to the County for acceptance before starting work. The certificates of insurance must contain a provision that coverage afforded under the policies will not be cancelled until at least 30 days prior written notice has been given to the County, or 10 days' notice if cancellation is due to nonpayment of premium.

Do not allow any subcontractor to commence work until the insurance required of the subcontractor has been obtained.

Any violation of the requirements of section 7 constitutes a material breach of the entire agreement.

Certificates evidencing the issuance of insurance as listed in section 7-1.06B(2) must be filed with the County within 10 days after the date of execution of this agreement by you and before the start of work.

7-1.06B(2) Liability Limits

7-1.06B(2)(i) Workers' Compensation Insurance and Employer's Liability Insurance

You and your subcontractors must obtain and maintain for all employees engaged in the work. Provide Employer's Liability Insurance in amounts not less than \$1,000,000 per occurrence.

7-1.06B(2)(ii) Commercial General Liability (Form CG 20 10 11 85)

You must obtain and maintain for yourself and all your employees, during the course of this agreement, Commercial General Liability Insurance (Occurrence Form CG 0001) for bodily injury and property damage in an amount of not less than \$5,000,000 combined single limit coverage per occurrence and if the policy includes an aggregate limit, the aggregate limit must be at least \$10,000,000 for the following coverage:

1. Personal injury

Carry Comprehensive Automobile Liability Insurance, both bodily injury and property damage, on owned, hired, leased and non-owned automobiles used in connection with your business in an amount not less than \$1,000,000 combined single-limit coverage per occurrence.

7-1.06C Subcontractors

You must include all subcontractors as insured under the policies or furnish separate certificates and endorsements to the County for approval for each subcontractor. All insurance coverage for subcontractors is subject to each of the requirements in section 7 and must contain the additional insured endorsements required of you described under section 7.

7-1.06D Additional Insured Endorsement

The Commercial General Liability and Automobile Liability Insurance must each contain, or be endorsed to contain, the following provision:

The County, its officers, officials, employees, designated agents, and appointed volunteers must be named as additional insureds and must be added in the form of an endorsement to your insurance on Form CG 20 10 11 85. You must not commence work under this agreement until Form CG 20 10 11 85 is delivered to the County. This provision is not intended to extend to construction contractors contracted by the County to perform the work of improvement.

Coverage must not extend to any indemnity coverage for the active negligence of the additional insured in any case where an agreement to indemnify the additional insured would be invalid under subdivision (b) of California Civil Code Section 2782.

7-1.06E Other Insurance Provisions

For any claims related to the work performed under this agreement, your insurance coverage must be primary insurance as to the County, its officers, officials, employees, designated agents and appointed volunteers. Any insurance or self-insurance maintained by the County, its officers, officials, employees, designated agents or appointed volunteers must be in excess of your insurance and must not contribute with it.

Any deductibles or self-insured retentions must be declared to and approved by the County. At the option of the County, either you must reduce or eliminate such deductibles or self-insurance retentions as they apply to the County or you must provide a financial guarantee satisfactory to the County guaranteeing payment of losses and related investigations, claim administration, and defense and defense-related expenses.

Insurance coverage required of you under this agreement must be placed with insurers with a current A.M. Best rating of no less than A:VII.

Insurance coverage in the minimum amounts must not be construed to relieve you for liability in excess of such coverage, nor will it preclude the County from taking other action as is available to it under any other provision of this agreement or applicable law. Failure of the County to enforce in a timely manner any of the provisions of section 7 will not act as a waiver to enforcement of any of these provisions at a later date.

If any insurance coverage required by this agreement is provide on a "Claims Made", rather than "occurrence" form, you agree to maintain required coverage for a period of three years after the expiration of this agreement (Post Agreement Coverage) and any extensions. You must maintain the required Post Agreement Coverage by renewal or purchase of prior acts or tail coverage. This sub-provision is contingent upon the Post Agreement Coverage being both available and reasonably affordable in relation to the coverage provided during the term of this agreement. For purposes of interpreting this requirement, a cost

not exceeding 100% of the last annual policy premium during the term of this agreement in order to purchase prior acts or tail coverage for Post Agreement Coverage must be deemed to be reasonable.

You agree to waive all rights of subrogation against the County, its officers, officials, employees, agents, and volunteers for losses arising from work performed by you under this agreement.

The County will include a provision in its Contract with the general contractor hired to perform the work of improvements requiring that the general contractor and all of its subcontractors maintain general liability insurance of not less than \$1,000,000 and that such insurance include the County, its officers, officials, employees, designated agents and appointed volunteers as additional insureds.

8 PROSECUTION AND PROGRESS

Replace section 8-1.02 with:

The Contractor shall provide the County with a detailed schedule and detour plan indicating how the project will be constructed prior to beginning of work. Full compensation for preparation of the detailed schedule and detour plan indicating how the project will be constructed shall be considered as included in the contract prices paid for various items of work and no additional compensation will be allowed therefor.

Replace *Reserved* in section 8-1.04C with:

Section 8-1.04B does not apply.

Start job site activities on the date stated in the Notice to Proceed. If no date specified, start work within fifteen (15) calendar days of receiving the Notice to Proceed. This work shall be diligently prosecuted to completion before the expiration of **130** WORKING DAYS.

The Contractor shall pay to the County of Imperial the sum of **\$3,400.00 per day**, for each and every calendar day's delay in finishing the work in excess of the number of working days prescribed above.

You may enter the job site only to measure controlling field dimensions and locate utilities.

You may start job site activities before the **15th** day after Contract approval if you:

1. Obtain specified authorization or acceptance for each submittal before the **15th** day
2. Receive authorization to start

Submit a notice 72 hours before starting job site activities.

9 PAYMENT

Add to section 9-1.03:

PROMPT PAYMENT OF WITHHELD FUNDS TO SUBCONTRACTORS

The agency shall hold retainage from the prime contractor and shall make prompt and regular incremental acceptances of portions, as determined by the agency, of the contract work, and pay retainage to the prime contractor based on these acceptances. The prime contractor, or subcontractor, shall return all monies withheld in retention from a subcontractor within 30 days after receiving payment for work satisfactorily

completed and accepted including incremental acceptances of portions of the contract work by the agency. Federal law (49CFR26.29) requires that any delay or postponement of payment over 30 days may take place only for good cause and with the agency's prior written approval. Any violation of this provision shall subject the violating prime contractor or subcontractor to the penalties, sanctions and other remedies specified in Section 7108.5 of the Business and Professions Code. These requirements shall not be construed to limit or impair any contractual, administrative, or judicial remedies otherwise available to the prime contractor or subcontractor in the event of a dispute involving late payment or nonpayment by the prime contractor, deficient subcontract performance, or noncompliance by a subcontractor.

Replace *Department's* in the 5th paragraph of section 9-1.07A with:

Caltrans

Replace section 9-1.11 with:

9-1.11 RESERVED

Delete item 3 in the list in the 1st paragraph of section 9-1.16A

Add to section 9-1.16D:

9-1.16D(4) PAYMENT

The contract lump sum price paid for "Mobilization" shall include full compensation for furnishing all labor, materials, tools, equipment and incidentals, and for doing all the work involved in mobilization as specified herein and no additional compensation shall be allowed therefor.

Add to section 9-1.16E(1):

The bid amount of the contract items of work is the maximum value the County recognizes for progress payment purposes unless approved change order work increases this amount.

After acceptance of the contract pursuant to the provisions in Section 5-1.46, "Final Inspection and Contract Acceptance," of the Standard Specifications, the amount, if any, payable for a contract item of work in excess of the maximum value for progress payment purposes for the item, will be included for payment in the first estimate made after acceptance of the contract.

No payment will be made for any materials on hand which are furnished but not incorporated in the work.

The final payment of five percent (5%) of the value of work under this contract, if unencumbered, shall be made thirty-five (35) days after acceptance of work by owner.

Replace the paragraphs of section 9-1.16F with:

The County will withhold 5 percent of all progress payments as retention. Retention will be paid to you on the Final Payment.

You will have the right to substitute securities for the retention under Pub Cont. Code § 22300. No substitution will be accepted until:

1. County approves the securities and their value,
2. Parties have entered into an escrow agreement (if the securities are to be held in escrow) in a form substantially similar to that under § 22300,
3. All documentation necessary for assignment of the securities to the County or to the escrow agent are delivered in a form satisfactory to the County.

If you have substituted securities for any of the retention, the County may request that such securities be revalued from time to time, but not more often than monthly. Such revaluation will be made by a person or entity designated by the County and approved by you. If such revaluation results in a determination that the securities have a market value less than the amount of retention for which they were substituted, then the amount of the retention required under the Contract will be increased by such difference in market value. Such increased retention will be withheld from the next progress payment(s) due to you under the Contract.

Replace the 3rd and 4th paragraphs of section 9-1.17D(3) with:

The Director of Public Works will make the final determination of any claims which remain in dispute after completion of claim review by the Engineer's authorized representative.

For claims of \$375,000 or less, the County and the Contractor agree to follow and comply with the mediation, arbitration, claim, civil action procedure and trial de novo provisions under California Public Contracts Code § 20104, 20104.2 and 20104.4.

RESOLUTION OF CLAIMS

Compliance with all change order procedures is a prerequisite to filing a Public Contract Code Claim pursuant to this Section. Claims must be submitted no later than (a) 30 days after the dispute resolution process set forth in Section 5-1.43 is complete or (b) 30 days after the occurrence of the event giving rise to the claim.

In accordance with the procedures set forth in Public Contract Code Sections 9204 and 20104-20104.6, a Contractor may submit a claim by registered or certified mail with return receipt requested, for one or more of the following: (a) a time extension, including, without limitation, for relief from damages or penalties for delay assessed by the County; (b) payment by the County of money or damages arising from work done by, or on behalf of, the Contractor pursuant to this contract and payment for which is not otherwise expressly provided or to which the Contractor is not otherwise entitled; or (c) payment of an amount that is disputed by the County.

The Contractor shall furnish reasonable documentation to support the claim, including but not limited to: 1) a clear, concise recital of the basis upon which the claim is asserted, including a designation of the provisions of the Contract upon which the claim is based, 2) a statement as to the amount of time and/or compensation sought pursuant to the claim; 3) whether the Contractor's claim arises from an ongoing occurrence, and if so a description of the specific Work activities affected by the claim, 4) a time impact analysis in the event that Contractor requests a time extension, 5) full and complete cost records supporting the amount of any claim for additional compensation and 6) a notarized certification by the Contractor as follows: "Under the penalty of law for perjury or falsification and with specific reference to the California False Claims Act, Government Code Section 12650 et seq., the undersigned hereby certifies that the information contained herein is a true, accurate and complete statement of all features relating to the claim asserted." Failure by the Contractor to provide sufficient documentation will result in denial of the claim.

The County reserves the right to request additional documentation, or clarification of the documentation provided.

Upon receipt of a claim, the County will conduct a reasonable review and provide a written statement to the Contractor identifying what portion of the claim is disputed and what portion is undisputed within 45 days of receipt of the claim. The County and Contractor may, by mutual agreement, extend the 45-day time period. For any undisputed portion of a claim, the County must make payment within 60 days of its issuance of the written statement.

If the Contractor disputes the County's written statement, or if the County fails to respond, the Contractor may demand an informal conference to meet and confer for settlement of the issues in dispute. The County will then schedule the meet and confer conference within 30 days of the demand. Within 10 business days following the meet and confer conference, the County will provide a written statement identifying the portion of the claim that remain in dispute. Any payment due on an undisputed portion of the claim will be made within 60 days of the meet and confer conference.

After the meet and confer conference, any disputed portion of the claim shall be submitted to non-binding mediation. Alternatively, upon receipt of a claim, the parties may mutually agree to waive, in writing, mediation and proceed directly to the commencement of a civil action or binding arbitration, as applicable. If mediation is unsuccessful, the parts of the claim that remain in dispute shall be subject to applicable procedures set forth below.

Failure of a public entity to respond to a claim within the time periods described above shall result in the claim being deemed rejected in its entirety. Additionally, amounts not paid in a timely manner shall bear interest at 7 percent per year.

In the event that the mediation is unsuccessful, Contractor must file a government claim pursuant to Government Code Sections 910 et seq. in order to initiate a civil action.

In any civil action filed to resolve claims, the court shall submit the matter to nonbinding mediation within 60 days following the filing or responsive pleading, provided that the parties have not already participated in mediation of the claim as outlined above. If the matter remains in dispute after nonbinding mediation, the court shall submit the matter to judicial arbitration pursuant to Code of Civil Procedure Section 1141.10 et seq. If the matter remains in dispute after judicial arbitration, the County or the Contractor may request a trial de novo.

Replace the paragraphs of section 9-1.22 with:

ARBITRATION

For claims of \$375,000 or less, the County and Contractor shall agree to follow and comply with the mediation, arbitration, claim, civil action procedure and trial de novo provisions set forth in California Public Contracts Code 20104, 20104.2 and 20104.4.

Any unresolved claims shall be resolved by litigation in a court of competent jurisdiction within the County of Imperial.

Add section 9:

SALES TAX CONDITION

Sales Tax Condition: The permittee is required to have a Construction Site Permit reflecting the project site address, ensuring all eligible sales tax payments are allocated to the County of Imperial, Jurisdictional Code

13998. The permittee will provide the County of Imperial with a copy of the CDTFA account number and sub-permit for its contractor and subcontractors (if any) related to the job site. The permittee shall provide written verification to the County Executive Office that the necessary sales and use tax permits have been obtained prior to the issuance of any grading permits.

Construction/Material Budget: Prior to a grading permit, the permittee will provide the County Executive Office with a construction materials budget, an official construction materials budget, or a detailed budget outlining the construction and materials cost for the processing facility on permittee letterhead.

County of Imperial will require that all qualifying contractors and subcontractors exercise their option to obtain a California Department of Tax and Fee Administration (CDTFA) sub-permit for the jobsite and allocate all eligible use tax payments to Imperial County and LTA.

Prior to commencement of any construction activity at the Project Site, County of Imperial shall require that the contractor or subcontractor provide County with a copy of their CDTFA account number and sub-permit. County of Imperial shall either cause its construction contractor to treat the Project in accordance with California Sales and Use Tax Regulation 1521(b)(2)(B), California Sales and Use Tax Regulation 1521(c)(13)(B), and California Sales and Use Tax Regulation 1826(b) for sales and use tax purposes, or form a "Buying Company" as defined in the California Sales and Use Tax Regulation 1699(h). County of Imperial may adopt an alternate methodology to accomplish this goal if such methodology is approved by the County's Executive Officer, which approval shall not be unreasonably withheld or delayed, prior to issuance of any building permit.

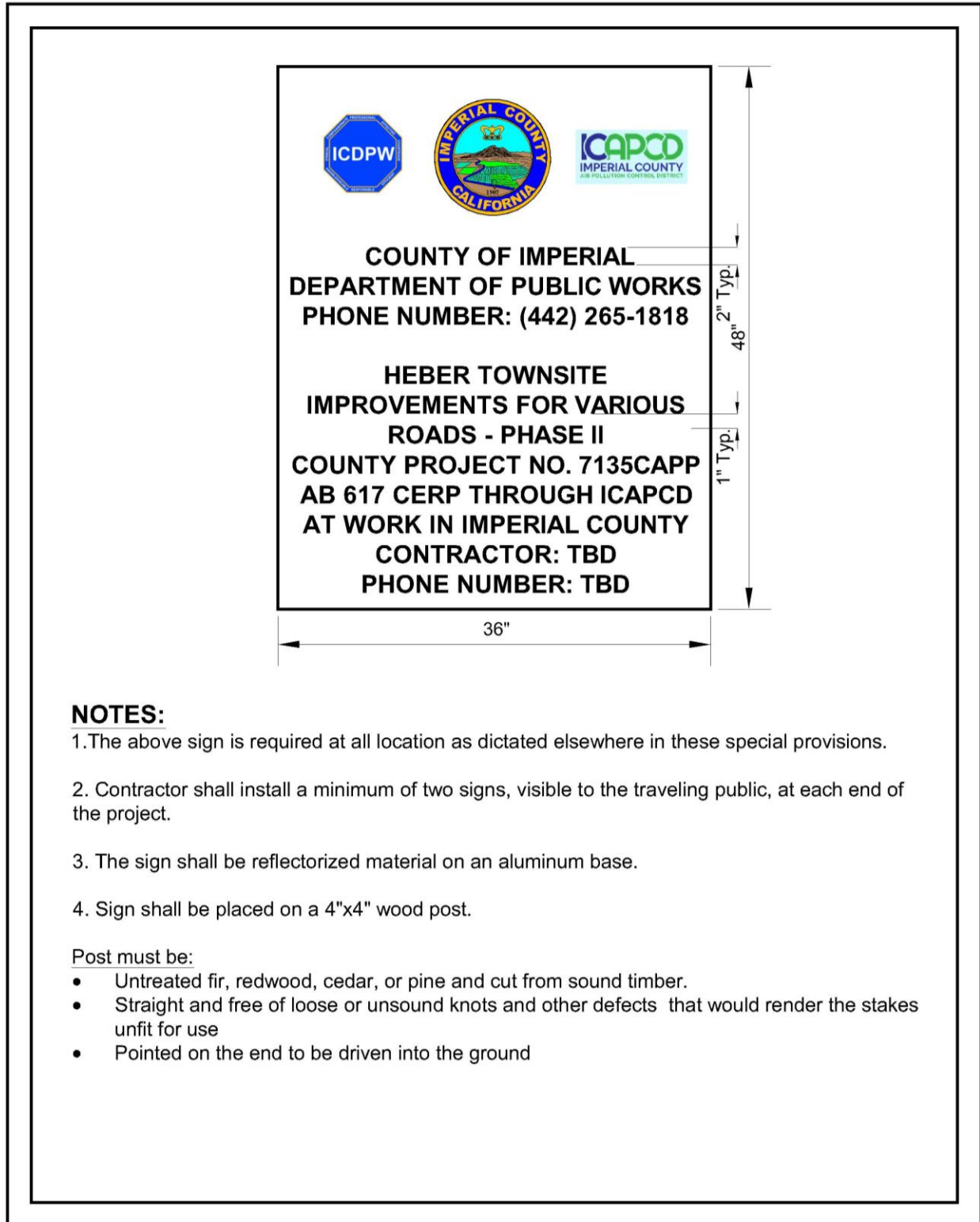
No later than forty-five (45) days after the due date for filing sales and use tax returns for each calendar quarter, occurring after the commencement of any construction activity on-site through and including the first anniversary of commercial operating date ("COD"), Contractor shall report to County of Imperial, the total amount of sales and use taxes related to the Project that are allocated to the County, and reported on County of Imperial's, general contractor's and subcontractors' applicable California sales and use tax returns.

Guarantee Amounts. Prior to the issuance of any building permit for the Project, Contractor shall provide County with a guarantee of the minimum sales and use taxes (based on a total construction and materials budget for the Project) that will be received by County and LTA under existing applicable sales and use tax laws. Contractor warrants that the sales/use tax guarantee amounts to be provided to County as mandated in this paragraph shall be true and accurate estimates of the projected sales and use taxes that will be generated for this Project. Contractor shall provide County with evidence of the projected sales/use taxes for the Project, including but not limited to sales tax receipts, and executed or anticipated engineering contracts, procurement contracts, and construction contracts. If the Parties are unable to agree upon a guarantee amount, then the dispute shall be referred to an independent accountant mutually acceptable to both Parties. The costs for such nonbinding mediation shall be borne by Contractor. Contractor warrants that the sales/use tax guarantee amounts to be provided to County as mandated in this paragraph will incorporate any and all sales/use tax exemptions that Contractor and/or its subcontractors intend to utilize, and that such exemptions will be disclosed to County fully and in good faith prior to the issuance of any building permit for this Project. Contractor understands and acknowledges that the sales/use tax guarantee amounts to be provided to County as mandated by this paragraph are a part of the consideration to be received by County in return for entering into this Agreement, and further understands and acknowledges that County would not enter into this Agreement but for said guarantee from Contractor. In the event that County and / or LTA receives less than the amount of sales / use taxes guaranteed pursuant to this paragraph, then Contractor shall pay, as and when provided below, to County or LTA as applicable, the amount of the applicable shortfall.

12 TEMPORARY TRAFFIC CONTROL

Provide a minimum of two Imperial County project identification signs (Sign 1). Posting of the current wage determinations, OSHA, and other applicable posters and notifications is required for the project in accordance with the California labor laws for Public Works Projects. The location of the signs to be installed will be determined by the Engineer and the County of Imperial Representative(s).

Delete the paragraphs of section 12-3.11B(5)(b)

Replace *Not Used* in section 12-3.11D with:

PAYMENT

Full compensation for furnishing, installing, and maintaining Construction Area Signs, including all temporary signs and object markers required for the direction of traffic through or within the project limits, Imperial County project identification signs, and project funding signs, shall be considered as included in the contract lump sum price paid for “Temporary Traffic Control” and no additional compensation shall be allowed therefor.

Replace *Reserved* in section 12-4.02C(3)(d) with:

Road shall remain open to traffic at all times.

Legal and safe access shall be provided and maintained to all properties throughout the construction period as required. Access shall accommodate emergency safety vehicles as required.

Add to the end of the 1st paragraph of section 12-4.02C(7)(a):

Except you may use a moving closure during traffic striping and pavement marker placement using a bituminous adhesive. Do not use a moving lane closure when grinding for recessed striping and recessed markers.

Replace section 12-4.02D with:

PAYMENT

Minor deviations from the requirements of this section concerning hours of work which do not significantly change the cost of the work may be permitted upon the written request of the Contractor if, in the opinion of the Engineer, public traffic will be better served and the work expedited. These deviations shall not be adopted by the Contractor until the Engineer has approved the deviations in writing. Other modifications will be made by contract change order.

Full compensation for providing the Traffic Control Plan, including furnishing, placing, maintaining, and removing temporary traffic control devices and temporary pavement striping/markings as part of the “Traffic Control System” shall be considered as included in the contract lump sum price paid for “Temporary Traffic Control” and no additional compensation shall be allowed therefor.

Replace 2nd paragraph of section 13-2.01A with:

Preparing a water pollution control program or stormwater pollution prevention plan includes developing and implementing the Water Pollution Control Program (WPCP) or Stormwater Pollution Prevention Plan (SWPPP), providing a WPC manager, conducting WPC training, and monitoring, sampling, testing, reporting, inspecting and correcting WPC practices. The Contractor can find a draft WPCP or SWPPP as part of the Information Handout (Attached) for reference. The said Draft WPCP or SWPPP was prepared under the Construction General Permit Order 2022-0057-DWQ.

This project's Water Pollution Control Program includes the preparation, finalization, and implementation of WPCP or SWPPP in accordance with the Construction General Permit. This project is subject to the NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) GENERAL PERMIT FOR STORMWATER DISCHARGES ASSOCIATED WITH CONSTRUCTION AND LAND DISTURBANCE ACTIVITIES (GENERAL PERMIT) ORDER WQ 2022-0057-DWQ NPDES NO. CAS000002. The Contractor shall provide a Qualified SWPPP Practitioner (QSP) and Developer (QSD) to assist the Owner with filing the Notice of Intent (NOI), annual report(s), Notice of Termination (NOT), and other required documents or reports in the SMARTS system. The Contractor's QSP or QSD shall provide and upload the supplemental documents such as pre- and post-construction photographs, facility/site map, final inspection reports, post construction related documents, etc., as required by SMARTS system and as required by the Owner.

Replace section 13-2.04 with:

PAYMENT

Full compensation for preparation of a Water Pollution Control Program or Stormwater Pollution Prevention Plan shall be considered as included in the contract price paid per lump sum for "Water Pollution Control" and no separate or additional payment shall be considered therefor.

Replace section 13-3 with:

PART 1 – GENERAL

1.01 DESCRIPTION OF WORK

- A. The Contractor shall furnish all labor, materials, tools, supervision, transportation, and equipment necessary to perform all Work required to comply with all applicable local, state, and federal regulations and permits associated with Erosion and Sediment Control.
- B. Work activities require the project to be in compliance with “National Pollutant Discharge Elimination System (NPDES) General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities, Order No. 2022-0057-DWQ.”
- C. The Stormwater Pollution Prevention Plan (SWPPP) for the site shall be implemented and amended as necessary by the Contractor. The Contractor can find a conceptual SWPPP as part of the Information Handout. If amendment of the SWPPP is required, Contractor shall submit request to the Resident Engineer and the Qualified Developer of the SWPPP contracted by the Contractor shall prepare the amendment.

1.03 SUBMITTALS

A. The Contractor shall submit the following to the Construction Manager 10 days prior to commencement of the Site Work:

1. Submit 3 copies of the SWPPP updated to incorporate the means and methods of the Contractor's planned construction and allow 5 working days for the Construction Manager's review. If revisions are required, the Construction Manager will provide comments to the Contractor in a timely manner.

2. Contractor is to change and resubmit the SWPPP within 3 working days of receipt of the Construction Manager's comments. The Construction Manager's review resumes when the revised SWPPP is resubmitted.

3. Submit an electronic and 4 printed copies of the revised SWPPP. The electronic copy shall be in PDF format and include all signed signature pages, Site Maps, and components required by the California Construction General Permit. The electronic copy shall additionally be posted to SMARTS by the Contractor's DEP.

4. If the Construction Manager requests changes to the SWPPP based on RWQCB comments, amend the SWPPP within 5 working days.

B. The Contractor shall submit all inspection reports and documents as required by the CA CGP, including but not limited to:

1. Rain Event information for Qualifying Rain Events (QRE) and associated storm event monitoring data. QRE and sampling data shall be submitted to the CM within 5 days of sample collection.

2. NAL Exceedance Reports, if requested by the RWQCB, in accordance with permit requirements.

3. Inspection Reports (Routine BMP, Pre-Storm, Post-Storm, During Storm, and Quarterly Non-Storm Water). Submit to the CM on a monthly basis.

C. Annual Reports

1. The Contractor shall complete the Stormwater Annual Report, using forms on SMARTS system for the reporting period of July 1 to June 30, or the Contractor's period of work if work is performed during a subset of the annual reporting period.

2. If construction occurs from July 1 through June 30, submit to Construction Manager no later than July 15 for the prior reporting period.

3. If construction ends before June 30, then submit to Construction Manager within 15 calendar days after completion of all Work on the contract.

4. The Contractor shall follow this process for Stormwater Annual Report submittal:

a. Submit 2 hard copies of the Stormwater Annual Report and allow 10 working days for the Construction Manager's review. The Annual Report should be generated using project-specific forms on the SMARTS system and be completed by the DEP. Hard copies to be generated after the completion check in SMARTS by printing a pdf from SMARTS for the Owner representative's review. If revisions are required, the Construction Manager provides comments and specifies the date that the review stopped.

b. Change and resubmit the Stormwater Annual Report, by updating forms in SMARTS and regenerating a printed version, within 5 working days of receipt of the Construction Manager's comments. The Construction Manager's review resumes when the revised Stormwater Annual Report is resubmitted.

c. When the Construction Manager accepts the Stormwater Annual Report, the LRP will certify the Annual Report in SMARTS.

d. The contractor shall submit an electronic and 2 printed copies of the accepted Stormwater Annual Report. Electronic copy shall be in PDF format.

PART 2 – PRODUCTS

2.01 MATERIALS

A. Materials used for Erosion and Sediment Control including, but not limited to, fiber rolls, sand bags, gravel bags, and other best management practices as illustrated on the erosion control plans and details shall conform to the requirements outlined in the SWPPP.

PART 3 – EXECUTION

3.01 GENERAL

A. The Contractor is advised that work under this contract shall be subject to the requirements of the National Pollutant Discharge Elimination System (NPDES) general requirements.

The Contractor shall be responsible for:

1. Filing Notice of Intent (NOI); any Change of Information (COI), Annual Reports; and Notice of Termination (NOT) within the existing project in SMARTS. The Contractor shall prepare and pay for the filing of the NOI and COI, as applicable.

2. Update the Storm Water Pollution Prevention Plan (SWPPP) as necessary for the construction of this project. Construction related activities, including but not limited to the elements of the SWPPP, shall be performed to eliminate both storm water and nonstorm discharges to storm water control system, by Contractor and subcontractor(s). The Construction Manager will notify the Contractor of any non-compliance with the foregoing stipulations and appropriate actions shall be taken promptly. The Contractor shall also notify the Construction Manager of any conditions which could lead to noncompliance with the permit requirements.

B. The Contractor shall not be entitled to any time extensions or compensation for any cost due to any action required as a result of Contractor's failure to comply with those provisions of the SWPPP within Contractor's control. Contractor will be responsible for ensuring that Contractor's subcontractor(s) comply with the provisions of this Section. Contractor shall be liable for any action or fine imposed by the regulatory agencies on those incidents of noncompliance which are within Contractor's area of responsibility.

C. The Contractor shall exercise every reasonable precaution to protect canals, channels, storm drains and bodies of water from pollution, including siltation arising from Contractor's operations, or erosion siltation from completed areas. Pollution control work shall consist of implementing practices or constructing facilities in accordance with local, state, or federal regulations which may be required to provide for retention and control of pollutants. The Contractor shall control site water in accordance with applicable permits.

D. The Contractor shall:

1. Control and manage storm water runoff;
2. Control discharges from dewatering activities;
3. Direct use of water for dust control;
4. Control water levels in all storm water sedimentation ponds on the site; and
5. Remove ponded water on-site within 72 hours.

E. At the completion of each work day, the Contractor shall take all necessary preventive measures to avoid or minimize damage resulting in erosion or impounding caused by storm water runoff within the construction area. Erosion control measures shall consist of constructing sandbag berms, desilting basins, drains, temporary storm water pumping facilities, and other such measures required to provide for the prevention, control and abatement of storm water discharges and damage resulting therefrom. The cost for any repairs due to such damage shall be the sole responsibility of the Contractor. Adequate runoff water control shall be maintained at all times in waste excavation areas so that water is prevented from flowing from areas where waste is exposed to uncontaminated areas.

F. The Contractor shall install temporary drainage piping to control overland flow, route natural drainage under temporary roadways, and intercept groundwater flows, if necessary. The Contractor shall select the size and type of piping to be used, and shall be responsible for the performance of the temporary piping. The Contractor shall adequately compact materials around the drainage piping to ensure protection of the piping and adequacy of fill over the piping. The Contractor shall perform regular maintenance of any temporary piping as necessary to prevent plugging or reduced capacity.

G. Water coming into contact with waste shall be handled and disposed of as contaminated.

H. It is anticipated that nuisance water, such as rainfall or surface runoff, may be encountered within the construction site during the period of construction under this contract. The Contractor, by submitting their bid, will be held to have investigated the risks arising from such waters and to have made their bid in accordance therewith.

I. The Contractor shall at all times protect the work from damage by such waters and shall take all due measures to prevent delays in progress of the work caused by such waters. The cost for any repairs due to such damage shall be the responsibility of the Contractor. The Contractor shall dispose of nuisance water at their own expense and without adverse effects upon the work site or any other property.

4.01 GENERAL

Replace section 13-6.04 with:

PAYMENT

Full compensation for furnishing, placing, maintaining, and removing Temporary Fiber Rolls specified in these specifications, special provisions and as directed by the Engineer shall be considered as included in the contract price paid per lump sum for "Water Pollution Control" and no separate or additional payment shall be considered therefor.

The payment quantity for temporary fiber roll does not include the additional quantity used for overlaps.

24 performance of the obligations assumed by CONTRACTOR hereunder; including but not
25 limited to any additional work or change orders agreed upon pursuant to written
26 authorization as described in Section 5. Proposed additional work or change order requests,
27 when applicable, will be attached and incorporated herein under **Exhibit "B"** (as "B-1," "B-
28 2," etc.).

1 **4. TRENCHING REQUIREMENTS AND UTILITY RELOCATION.**

2 **4.1. Four Feet (4') Below the Surface.** In the event the Project involves digging trenches or
3 other excavations that extend deeper than four feet (4') below the surface,
4 CONTRACTOR shall:

5 **4.1.1.** Promptly, and before the following conditions are disturbed, notify COUNTY, in
6 writing, of any:

- 7 (a) Material that CONTRACTOR believes may be material that is hazardous
8 waste, as defined in Health & Safety Code §25117, that is required to be
9 removed to a Class I, Class II or Class III disposal site in accordance with
10 provisions of existing law;
11 (b) Subsurface or latent physical conditions at the site differing from those
12 indicated by information about the site made available to bidders prior to
13 the deadline for submitting bids; and
14 (c) Unknown physical conditions at the site of any unusual nature, different
15 materially from those ordinarily encountered and generally recognized as
16 inherent in work of the character provided for in the Agreement.

17 **4.1.2.** In response to any written notice generated pursuant to Subparagraph 4.1.1,
18 COUNTY shall promptly investigate the conditions, and if it finds that the
19 conditions do materially so differ, or do involve hazardous waste, and cause a
20 decrease or increase in CONTRACTOR's cost of, or the time required for,
21 performance of any part of the Work, COUNTY shall issue a change order under
22 the procedures described in this Agreement.

23 **4.1.3.** In the event that a dispute arises between COUNTY and CONTRACTOR whether
24 the conditions materially differ, or involve hazardous waste, or cause a decrease
25 or increase in CONTRACTOR's cost of, or time required for, performance of any
26 part of the Work, CONTRACTOR shall not be excused from any scheduled
27 completion date provided for by this Agreement, but shall proceed with all Work
28 to be performed under this Agreement. CONTRACTOR shall retain any and all

rights provided either by contract or by law which pertain to the resolution of disputes and protests between the Parties.

4.2. Trenching Requirements – Project in Excess of Twenty-Five Thousand Dollars (\$25,000) and Five Feet (5') Below the Surface.

For projects involving both an estimated expenditure in excess of twenty-five thousand dollars (\$25,000) and the excavation of any trench five feet (5') or more in depth, CONTRACTOR shall submit a detailed plan showing the design of shoring, bracing, sloping or other provisions to be made for worker protection from the hazard of caving ground during the excavation of such trench. The plan must be accepted by COUNTY (or by a registered civil or structural engineer, employed by COUNTY, to whom authority to accept has been delegated) in advance of excavation. If such plan varies from the shoring system standards, the plan shall be prepared by a registered civil or structural engineer. Nothing in this Paragraph shall allow CONTRACTOR to use a shoring, sloping, or protective system less effective than that required by California Construction Safety Orders. Further, nothing in this Paragraph shall be construed to impose tort liability on COUNTY or any of its employees.

4.3. Utilities Relocation. In the event that CONTRACTOR, in the scope of work, encounters utilities not shown on COUNTY'S plans, COUNTY shall compensate CONTRACTOR for utilities relocation work. COUNTY shall also waive liquidated damages for any delay that occurs as a result of said encounter and/or relocation of utilities.

5. CHANGE ORDERS.

5.1. Change Orders. CONTRACTOR shall make no changes to the Work to be performed pursuant to this Agreement, including but not limited to additions, deletions, modifications or substitutions, nor shall CONTRACTOR perform any extra work (collectively, "Change Order Work") without the prior written consent of COUNTY. If CONTRACTOR encounters conditions it considers different from those described in **Exhibit "A"** to this Agreement, CONTRACTOR may request a change order in conformance with COUNTY's standard procedure ("Change Order"). If COUNTY approves the request, CONTRACTOR will execute a Change Order and CONTRACTOR's execution of the Change Order shall

confirm approval thereof. COUNTY may order additional work, and CONTRACTOR shall perform such changes in the Work as directed by COUNTY in any Change Order prepared by CONTRACTOR. COUNTY's rights to eliminate portions of the Work or to initiate a Change Order shall not be limited in any way. The Change Order shall be in writing and shall include:

5.1.1. Any and all supporting documents and drawings depicting the source and location of the desired change, and explain in detail the field conditions and reasons for the requested change;

5.1.2. Any change or adjustment to the compensation set forth in this Agreement as a result of changes in the Work based on a lump sum or time and material basis, as may be directed by COUNTY; and

5.1.3. Any request for adjustments to time for completion of the Project.

5.2. Payment for Change Order Work. CONTRACTOR shall not be entitled to receive any compensation for work, labor, materials or changes of any kind, regardless of whether ordered by COUNTY or any of its representatives, unless a Change Order has been submitted in writing and approved prior to the commencement of any Change Order Work as described above. If the changes are required by any inspecting governmental agencies or utility companies, or are otherwise required to comply with any codes, laws, rules or regulations, including those set forth in this Agreement, then CONTRACTOR shall not be entitled to any increases in the compensation set forth in this Agreement or other compensation as a result of the changes.

5.3. Disputed Change Order Work. Any dispute concerning the performance of such Change Order Work or the amount of compensation to be paid to CONTRACTOR by COUNTY shall not affect CONTRACTOR's obligation to perform such Change Order Work. CONTRACTOR agrees that it shall timely complete all Change Order Work even if there shall be a dispute between CONTRACTOR and COUNTY over the amount or scope of the Change Order Work. CONTRACTOR shall have the right to be compensated for any undisputed Change Order Work amounts as determined to be undisputed in COUNTY's

sole discretion.

5.4. Authorized Representative. No Change Order shall be valid or binding against COUNTY unless such Change Order has been executed by COUNTY's designated representative, who is the Director of Public Works. COUNTY shall notify CONTRACTOR in writing if the designated representative is changed.

5.5. Limits. When applicable, the authority to execute a Change Order on this Project shall not exceed the amount allowed by law pursuant to Public Contract Code sections 20137-20142 et seq. Where Change Orders are in an amount between ten percent (10%) and twenty-five percent (25%) of the amount set forth in this Agreement and based on a need for additional quantities due to an increase in the unit quantities required to complete the project in excess of the COUNTY's Engineer's estimate of unit quantities as set forth in the Invitation to Bid, CONTRACTOR shall be paid pursuant to Public Contract Code sections 20143 and 20139 and section 4 of the Standard Specifications, State of California, Business, Transportation and Housing Agency, May 2006 Issued by the Department of Transportation ("Caltrans Standard Specifications") referred to in **Exhibit "A"** and incorporated herein by reference.

6. **REPRESENTATIONS BY CONTRACTOR.**

6.1. CONTRACTOR understands and agrees that COUNTY has limited knowledge in the construction specified in the description of work. CONTRACTOR has represented itself to be expert in these fields and understands that COUNTY is relying upon such representation.

6.2. CONTRACTOR represents and warrants that it is a lawful entity possessing all required licenses and authorities to do business in the State of California and perform all aspects of this Agreement.

6.3. CONTRACTOR shall not commence any work under this Agreement or provide any other services, or materials, in connection therewith until CONTRACTOR has received written authorization from the Director of Public Works, or his/her designee ("Notice to Proceed") to do so.

6.4. CONTRACTOR represents and warrants that the people executing this Agreement on behalf of CONTRACTOR have the authority of CONTRACTOR to sign this Agreement

and bind CONTRACTOR to the performance of all duties and obligations assumed by CONTRACTOR herein.

6.5. CONTRACTOR represents and warrants that any employee, contractor, subcontractor and agent who will be performing any of the duties and obligations of CONTRACTOR herein possess all required licenses and authorities, as well as the experience and training, to perform such tasks.

6.6. CONTRACTOR represents and warrants that the allegations contained in its Proposal are true and correct.

6.7. CONTRACTOR understands that COUNTY considers the representations made herein to be material and would not enter into this Agreement with CONTRACTOR if such representations were not made.

6.8. Retention and Access of Books and Records. CONTRACTOR represents and warrants that it shall maintain books, records, documents, reports and other materials developed under this Agreement as follows:

6.8.1. CONTRACTOR shall hold and possess as the property of COUNTY all papers, books, files, correspondence and other records of all kinds which at any time shall come into its possession or under its control relating only to services performed by CONTRACTOR under this Agreement for a minimum period of five (5) years, or for any longer period required by law, from the date said papers came into the possession of CONTRACTOR pursuant to this Agreement.

6.8.2. Any records or documents required to be maintained by CONTRACTOR pursuant to this Agreement shall be made available to COUNTY for inspection or audit, at any time during CONTRACTOR's regular business hours provided COUNTY provides CONTRACTOR with seven (7) days advanced written or oral notice. Copies of such documents shall, at no cost to COUNTY, be provided to COUNTY for inspection at CONTRACTOR's address indicated for receipt of notices under this Agreement.

6.8.3. CONTRACTOR shall surrender all papers maintained by CONTRACTOR

1 pursuant to Subparagraph 6.8.1 of this Agreement within thirty (30) days of
2 termination of this Agreement.

3 **6.8.4.** CONTRACTOR represents and warrants that it has not been engaged by, nor will
4 it be engaged by and owes no duty of performance to any other person or entity
5 that would constitute a conflict. For breach or violation of this warranty,
6 COUNTY shall amongst other remedies at law, have the right to terminate this
7 Agreement without liability, or at its sole discretion, to deduct from the
8 Agreement price or consideration, or otherwise recover the full amount of such
9 fee, commission, percentage brokerage fee, gift or contingent fee paid or received
10 from another entity or person.

11 **6.9.** CONTRACTOR shall perform pursuant to this Agreement in accordance with and in full
12 compliance with all applicable Federal, State and local statutes, rules, regulations and
13 policies and procedures, regardless of whether they are expressly set forth in this
14 Agreement. It is understood that in the event COUNTY is investigated or audited by any
15 State or Federal governmental agency, or any other recognized investigative/auditing
16 entity, CONTRACTOR shall fully cooperate with such agencies' reasonable and lawful
17 request for information.

18 **7. TERM OF AGREEMENT.**

19 This Agreement shall commence on the date first written above and shall remain in effect until
20 the services provided as outlined in Section 3, ("SCOPE OF WORK TO BE PERFORMED BY
21 CONTRACTOR"), have been completed, unless otherwise terminated as provided for in this Agreement.

22 **8. COMPENSATION.**

23 The total compensation payable under this Agreement shall be in accordance with the item prices
24 incorporated within the Proposal submitted by CONTRACTOR for labor, materials and all other services
25 related to the performance of this Agreement, attached hereto as **Exhibit "B"** and incorporated herein
26 as though fully set forth. The total compensation payable under this Agreement shall not exceed
27 <<Compensation Amount>>

28 **9. PAYMENT AND RETENTION OF FUNDS.**

COUNTY shall pay CONTRACTOR for completed and approved services upon presentation and approval of its itemized billing, subject to the following.

9.1. Retention.

9.1.1. In accordance with Cal. Pub. Contract Code §§ 7201 and 9203, COUNTY shall generally retain five percent (5%) of the total compensation payable under this Agreement until the Work to be performed has been completed in accordance with this Agreement, as determined by COUNTY, and payment in full of all of CONTRACTOR's subcontractors has been certified.

9.1.2. The 5% retention amount may be exceeded if the COUNTY's Board of Supervisors has approved a finding, during a properly noticed and normally scheduled public hearing conducted either prior to or concurrent with authorizing this Project to go out to bid, that the Project is substantially complex and therefore requires a higher retention amount than 5%. Should the retention amount exceed 5% for this Project, then the actual retention amount will be listed in the Plans and Specifications, along with the findings justifying the increased retention amount.

9.2. Substitution of Retention.

9.2.1. CONTRACTOR may elect to substitute securities for any retention of funds by COUNTY to ensure performance under this Agreement. At the request and expense of CONTRACTOR, securities equivalent to the amount retained shall be deposited with the COUNTY, or with a state or federally chartered bank in this state as the escrow agent, who shall then return the securities to CONTRACTOR once the Work to be performed has been completed in accordance with this Agreement, as determined by COUNTY, and payment in full of all of CONTRACTOR's subcontractors has been certified.

9.2.2. Alternatively, CONTRACTOR may request and COUNTY shall make payment of retentions earned directly to the escrow agent at the expense of CONTRACTOR. CONTRACTOR, at its sole cost and expense, may direct the investment of the payments into securities, and CONTRACTOR shall receive the interest earned on

1 the investments upon the same terms provided for in this Section for securities
2 deposited by CONTRACTOR. Once the Work to be performed has been
3 completed in accordance with this Agreement, as determined by COUNTY, and
4 payment in full of all of CONTRACTOR's subcontractors has been certified,
5 CONTRACTOR shall receive from the escrow agent all securities, interest, and
6 payments received by the escrow agent from COUNTY, pursuant to the terms of
7 this Section.

8 **9.2.3.** Securities eligible for investment under this Section shall include those listed in Cal.
9 Gov. Code § 16430, bank or savings and loan certificates of deposit, interest-bearing
10 demand deposit accounts, standby letters of credit, or any other security mutually
11 agreed to by COUNTY and CONTRACTOR. CONTRACTOR shall be the
12 beneficial owner of any securities substituted for retained funds and shall receive
13 any interest thereon.

14 **9.2.4.** Substitution of securities shall be conducted through an Escrow Agreement
15 substantially similar to that found in Cal. Pub. Contract Code § 22300(f).

16 **9.2.5.** Notwithstanding any other provision in this Section, substitution of securities is
17 prohibited where funding for the Project, in whole or in part, will be provided by
18 the Farmers Home Administration of the United States Department of Agriculture
19 pursuant to the Consolidated Farm and Rural Development Act (7 U.S.C. Sec. 1921
20 et seq.), or where otherwise disallowed by federal law.

21 **10. METHOD OF PAYMENT.**

22 **10.1.** CONTRACTOR shall at any time prior to the fifteenth (15th) day of any month, submit
23 to COUNTY's Director of Public Works or his/her designee, a complete and accurate
24 written claim for compensation for services performed. The claim shall be in a format
25 approved by COUNTY. COUNTY shall make no payment prior to the claims being
26 approved in writing by the Director of Public Works or his/her designee.

27 **10.2.** After determining that the claim is a proper payment request, the Director of Public
28 Works, or his/her designee, shall submit to COUNTY's Auditor/Controller undisputed

- 1 and properly submitted claims approved for payment within ten (10) days following the
2 date the claim was submitted to his/her Department.
- 3 **10.3.** CONTRACTOR may expect to receive payment within a reasonable time thereafter and
4 in any event in the normal course of business within thirty (30) days after the undisputed
5 and properly submitted claim is submitted.
- 6 **10.4.** Any claim determined to be an improper payment request shall be returned to
7 CONTRACTOR as soon as practicable, but not later than seven (7) days, after receipt with
8 a written explanation as to why the claim is an improper request for payment.
- 9 **10.5.** In order for prompt payment to be made by COUNTY pursuant to Public Contract Code
10 §20104.50, CONTRACTOR must properly fill out all written claims for compensation for
11 services performed.
- 12 **10.6.** COUNTY shall pay interest at the legal rate set forth in Code of Civil Procedure §685.010
13 in the event payment is not made within thirty (30) days of an undisputed properly submitted
14 request.
- 15 **11. INDEMNIFICATION.**
- 16 **11.1.** CONTRACTOR agrees to the fullest extent permitted by law to indemnify, defend,
17 protect and hold COUNTY and its representatives, officers, directors, designees,
18 employees, agents, successors and assigns harmless from any and all claims, expenses,
19 liabilities, causes of action, demands, losses, penalties, attorneys' fees and costs, in law
20 or equity, of every kind and nature whatsoever arising out of or in connection with
21 CONTRACTOR's negligent acts and omissions or willful misconduct under this
22 Agreement ("Claims"), whether or not arising from the passive negligence of COUNTY,
23 but does not include Claims that are finally determined to be the result of the sole
24 negligence or willful misconduct of COUNTY.
- 25 **11.2.** CONTRACTOR agrees to defend with counsel acceptable to COUNTY, indemnify and
26 hold COUNTY harmless from all Claims, including but not limited to:
- 27 **11.2.1.** Personal injury, including but not limited to bodily injury, emotional injury,
28 sickness or disease or death to persons including but not limited to COUNTY's

1 representatives, officers, directors, designees, employees, agents, successors and
2 assigns, subcontractors and other third parties and/or damage to property of
3 anyone (including loss of use thereof) arising out of CONTRACTOR's negligent
4 performance of, or willful misconduct surrounding, any of the terms contained in
5 this Agreement, or anyone directly or indirectly employed by CONTRACTOR or
6 anyone for whose acts CONTRACTOR may be liable;

7 **11.2.2.** Liability arising from injuries to CONTRACTOR and/or any of
8 CONTRACTOR's employees or agents arising out of CONTRACTOR's
9 negligent performance of, or willful misconduct surrounding, any of the terms
10 contained in this Agreement, or anyone directly or indirectly employed by
11 CONTRACTOR or anyone for whose acts CONTRACTOR may be liable;

12 **11.2.3.** Penalties imposed upon account of the violation of any law, order, citation, rule,
13 regulation, standard, ordinance or statute caused by the negligent action or
14 inaction, or willful misconduct of CONTRACTOR or anyone directly or
15 indirectly employed by CONTRACTOR or anyone for whose acts
16 CONTRACTOR may be liable, including but not limited to:

17 (a) Any loss of funding, penalties, fees, or other costs resulting from
18 CONTRACTOR's failure to adhere to Disadvantaged Business Enterprise
19 requirements and/or goals, as determined by COUNTY or such other
20 lawful entity in charge of monitoring Disadvantaged Business Enterprise
21 compliance;

22 (b) Any loss of funding, penalties, fees, or other costs resulting from
23 CONTRACTOR's failure to adhere to prevailing wage requirements, as
24 determined by COUNTY, the California Department of Industrial
25 Relations, or such other lawful entity in charge of monitoring prevailing
26 wage compliance;

27 **11.2.4.** Infringement of any patent rights which may be brought against COUNTY arising
28 out of CONTRACTOR's work;

11.2.5. Any violation or infraction by CONTRACTOR of any law, order, citation, rule, regulation, standard, ordinance or statute in any way relating to the occupational health or safety of employees; and

11.2.6. Any breach by CONTRACTOR of the terms, requirements or covenants of this Agreement.

11.3. The indemnification provisions of this Agreement shall extend to Claims occurring after this Agreement is terminated, as well as while it is in force.

12. INDEPENDENT CONTRACTOR.

12.1. In all situations and circumstances arising out of the terms and conditions of this Agreement, CONTRACTOR is an independent contractor, and as an independent contractor, the following shall apply:

12.2. CONTRACTOR is not an employee or agent of COUNTY and is only responsible for the requirements and results specified by this Agreement.

12.3. CONTRACTOR shall be responsible to COUNTY only for the requirements and results specified by this Agreement and except as specifically provided in this Agreement, shall not be subject to COUNTY's control with respect to the physical actions or activities of CONTRACTOR in fulfillment of the requirements of this Agreement.

12.4. CONTRACTOR is not, and shall not be, entitled to receive from, or through, COUNTY, and COUNTY shall not provide, or be obligated to provide, CONTRACTOR with Worker's Compensation coverage or any other type of employment or worker insurance or benefit coverage required or provided by any Federal, State or local law or regulation for, or normally afforded to, an employee of COUNTY.

12.5. CONTRACTOR shall not be entitled to have COUNTY withhold or pay, and COUNTY shall not withhold or pay, on behalf of CONTRACTOR, any tax or money relating to the Social Security Old Age Pension Program, Social Security Disability Program, or any other type of pension, annuity, or disability program required or provided by any Federal, State or local law or regulation.

12.6. CONTRACTOR shall not be entitled to participate in, or receive any benefit from, or

1 make any claim against any COUNTY fringe benefit program, including, but not limited
2 to, COUNTY's pension plan, medical and health care plan, dental plan, life insurance
3 plan, or any other type of benefit program, plan, or coverage designated for, provided to,
4 or offered to COUNTY's employee.

5 **12.7.** COUNTY shall not withhold or pay, on behalf of CONTRACTOR, any Federal, State,
6 or local tax, including, but not limited to, any personal income tax, owed by
7 CONTRACTOR.

8 **12.8.** CONTRACTOR is, and at all times during the term of this Agreement shall represent and
9 conduct itself as, an independent contractor, not an employee of COUNTY.

10 **12.9.** CONTRACTOR shall not have the authority, express or implied, to act on behalf of, bind
11 or obligate COUNTY in any way without the written consent of COUNTY.

12 **13. INSURANCE.**

13 **13.1.** CONTRACTOR hereby agrees at its own cost and expense to procure and maintain,
14 during the entire term of this Agreement and any extended term therefore, insurance in a
15 sum acceptable to COUNTY and adequate to cover potential liabilities arising in
16 connection with the performance of this Agreement and in any event not less than the
17 minimum limit set forth in the "Minimum Insurance Amounts" attachment to the Plans
18 and Specifications which are incorporated as if set forth fully herein.

19 **13.2. Special Insurance Requirements.** All insurance required shall:

20 **13.2.1.** Be procured from California admitted insurers (licensed to do business in
21 California) with a current rating by Best's Key Rating Guide, acceptable to
22 COUNTY. A rating of at least A-VII shall be acceptable to COUNTY; lesser
23 ratings must be approved in writing by COUNTY.

24 **13.2.2.** Be primary coverage as respects COUNTY and any insurance or self-insurance
25 maintained by COUNTY shall be in excess of CONTRACTOR's insurance
26 coverage and shall not contribute to it.

27 **13.2.3.** Name COUNTY as an additional insured on all policies, except Workers'
28 Compensation, and provide that COUNTY may recover for any loss suffered by

COUNTY by reason of CONTRACTOR's negligence.

13.2.4. State that it is primary insurance and regards COUNTY as an additional insured and contains a cross-liability or severability of interest clause.

13.2.5. Not be canceled, non-renewed or reduced in scope of coverage until after thirty (30) days written notice has been given to COUNTY. However, CONTRACTOR may not terminate such coverage until it provides COUNTY with proof that equal or better insurance has been secured and is in place. Cancellation or change without the prior written consent of COUNTY shall, at the option of COUNTY, be grounds for termination of this Agreement.

13.2.6. If this Agreement remains in effect more than one (1) year from the date of its original execution, COUNTY may, at its sole discretion, require an increase in the amount of liability insurance to the level then customary in similar COUNTY Agreements by giving sixty (60) days notice to CONTRACTOR.

13.3. Additional Insurance Requirements.

13.3.1. COUNTY is to be notified immediately of all insurance claims. COUNTY is also to be notified if any aggregate insurance limit is exceeded.

13.3.2. The comprehensive or commercial general liability shall contain a provision of endorsements stating that such insurance:

- (a) Includes contractual liability;
- (b) Does not contain any exclusions as to loss or damage to property caused by explosion or resulting from collapse of buildings or structures or damage to property underground, commonly referred to by insurers as the "XCU Hazards";
- (c) Does not contain a "pro rata" provision which looks to limit the insurer's liability to the total proportion that its policy limits bear to the total coverage available to the insured;
- (d) Does not contain an "excess only" clause which requires the exhaustion of other insurance prior to providing coverage;

- 1 (e) Does not contain an “escape clause” which extinguishes the insurer’s
2 liability if the loss is covered by other insurance;
3 (f) Includes COUNTY as an additional insured; and
4 (g) States that it is primary insurance and regards COUNTY as an additional
5 insured and contains a cross-liability or severability of interest clause.
- 6 **13.4. Deposit of Insurance Policy.** Promptly on issuance, reissuance, or renewal of any
7 insurance policy required by this Agreement, CONTRACTOR shall, if requested by
8 COUNTY, cause to be given to COUNTY satisfactory evidence that insurance policy
9 premiums have been paid together with a duplicate copy of the policy or a certificate
10 evidencing the policy and executed by the insurance company issuing the policy or its
11 authorized agent.
- 12 **13.5. Certificates of Insurance.** Complete copies of certificates of insurance for all required
13 coverages including additional insured endorsements shall be attached hereto as **Exhibit**
14 **“C”** and incorporated herein as though fully set forth.
- 15 **13.6. Additional Insurance.** Nothing in this, or any other provision of this Agreement, shall be
16 construed to preclude CONTRACTOR from obtaining and maintaining any additional
17 insurance policies in addition to those required pursuant to this Agreement.
- 18 **14. WORKERS’ COMPENSATION CERTIFICATION.**
- 19 **14.1.** Prior to the commencement of work, CONTRACTOR shall sign and file with COUNTY
20 the following certification: “I am aware of the provisions of California Labor Code
21 §§3700 et seq. which require every employer to be insured against liability for workers’
22 compensation or to undertake self-insurance in accordance with the provisions of that
23 code, and I will comply with such provisions before commencing the performance of the
24 work of this contract.”
- 25 **14.2.** This certification is included in this Agreement and signature of the Agreement shall
26 constitute signing and filing of the certificate.
- 27 **14.3.** CONTRACTOR understands and agrees that any and all employees, regardless of hire
28 date, shall be covered by Workers’ Compensation pursuant to statutory requirements

prior to beginning work on the Project.

14.4. If CONTRACTOR has no employees, initial here: _____.

15. **WARRANTY.**

15.1. **One Year Warranty.** CONTRACTOR agrees to provide a one-year warranty for all of its work and component parts and guarantees that all work shall be performed in a professional and workman-like manner and be free from defects. CONTRACTOR guarantees to timely correct all work performed by it under this Agreement which COUNTY determines to be defective in design, material and/or workmanship within a period of one (1) year from the date of the completion of the Work. The warranties set forth in this Agreement shall be in addition to, and not in lieu of, all other statutory and case law warranties and obligations of CONTRACTOR. CONTRACTOR expressly agrees that all warranties made by CONTRACTOR, all obligations under this Agreement and all remedies for breach of such warranties shall survive this Agreement in the event it is terminated or expires for any reason prior to the running of the full warranty periods listed above.

15.2. **Materials.** All materials furnished by CONTRACTOR shall be new, manufactured during the current year, of first quality and carrying full manufacturer's warranty. CONTRACTOR shall be responsible for any expiration of manufacturer or other warranties of material or equipment being supplied for this Agreement. CONTRACTOR guarantees that all warranties of material and equipment shall become effective when the project is accepted by COUNTY's Board of Supervisors, not at time of installation by CONTRACTOR.

15.3. **Manufacturers' Warranty Information.** CONTRACTOR agrees to promptly provide such information and maintenance recommendations to COUNTY at the inception of CONTRACTOR's work to the extent such information is reasonably available.

16. **DEFAULT AND REMEDIES.**

16.1. **Default.** In the event that (i) CONTRACTOR files a petition requesting relief under any bankruptcy act, or is adjudged as bankrupt, or makes a general assignment for the benefit

1 of creditors or has a receiver appointed on account of its insolvency, or (ii)
2 CONTRACTOR refuses or is unable, for whatever reason, to supply enough properly
3 skilled workers or proper materials to complete the Project, or (iii) CONTRACTOR fails
4 to follow the directions of COUNTY, or (iv) CONTRACTOR fails to make prompt
5 payment to its subcontractors and suppliers for materials or labor supplied or permits any
6 lien to be imposed upon all or any portion of the Project, or (v) CONTRACTOR
7 disregards any laws or orders of any public or private authority having jurisdiction over
8 the Work or the Project, or (vi) CONTRACTOR fails to perform in accordance with any
9 of the terms of this Agreement or breaches any provision of this Agreement, COUNTY
10 may give notice of such failure or breach to CONTRACTOR, identifying the failure or
11 breach of this Agreement. Should any such failure or breach continue for twenty-four
12 (24) hours after delivery of notice without a good faith effort on the part of
13 CONTRACTOR to commence all necessary corrective action, or should such a breach
14 continue despite CONTRACTOR's efforts for forty-eight (48) hours, then at that time
15 such failure shall be deemed a default by CONTRACTOR under this Agreement and
16 COUNTY shall have all rights and remedies available at law or in equity, including the
17 right to terminate this Agreement. Without limiting its rights and remedies, COUNTY
18 may then proceed as follows:

19 **16.1.1.** Without terminating this Agreement or the obligations of CONTRACTOR
20 hereunder as to all of the Work required to be performed or furnished by
21 CONTRACTOR pursuant to this Agreement, COUNTY may require
22 CONTRACTOR, at CONTRACTOR's expense, to cure such default(s) as may
23 exist in the performance of CONTRACTOR's obligations hereunder within forty-
24 eight (48) hours after such default(s) has/have occurred including but not limited
25 to repairing, replacing and correcting material or Work determined by COUNTY
26 to be defective or not complying with the requirements of this Agreement. Should
27 CONTRACTOR fail to timely repair, replace and/or correct non-complying or
28 defective materials and workmanship or otherwise cure its default(s) hereunder,

1 and in the case of emergencies in which case COUNTY may act immediately if
2 CONTRACTOR is not available or is not responding, and without further notice,
3 COUNTY may make required repairs, replacements and other corrections or
4 otherwise remedy the default by CONTRACTOR pursuant to the subparagraph
5 below.

6 **16.1.2.** Without terminating this Agreement or the obligations of CONTRACTOR
7 hereunder as to all of the Work required to be performed or furnished by
8 CONTRACTOR pursuant to this Agreement, COUNTY may engage another
9 contractor to perform such portion of CONTRACTOR's Work required pursuant
10 to this Agreement or furnish any materials or other items required hereunder as
11 COUNTY in its sole discretion may deem necessary to avoid delay in the progress
12 of the Work, and in connection therewith, COUNTY may perform such Work or
13 any portion thereof itself or have the same performed by others and COUNTY
14 may procure all necessary materials, equipment or other items required for the
15 continued progress of such Work. The costs incurred by COUNTY as a result of
16 engaging another contractor shall be deducted from the compensation payable
17 pursuant to this Agreement and if COUNTY's costs exceed or may reasonably be
18 anticipated to exceed the balance of the compensation due to CONTRACTOR for
19 such work, such excess, or anticipated excess, shall be immediately due and owing
20 from CONTRACTOR to COUNTY and may be withheld from any funds due to
21 CONTRACTOR pursuant to this Agreement or any other agreement.

22 **16.1.3.** COUNTY may terminate CONTRACTOR's right to perform upon written notice
23 and COUNTY shall then have the option of completing the Work or any portion
24 thereof by exercise of its interest under the performance bond issued in favor by
25 CONTRACTOR, or having such Work in whole or in part be completed by others
26 for CONTRACTOR's account. A calculation shall take place at the conclusion
27 of the Project wherein to the degree the sum of COUNTY's costs and any amounts
28 paid to complete the Project exceed the compensation payable pursuant to this

Agreement, then any such excess shall be immediately due and owing from
CONTRACTOR to COUNTY.

16.2. Damages. CONTRACTOR shall be liable for all damages suffered by COUNTY by reason of CONTRACTOR's default in any provision of this Agreement and the exercise of COUNTY of its option to terminate this Agreement shall not release CONTRACTOR of such liability. CONTRACTOR shall have no right to receive any further payment after a default has occurred until such time as the Work to be performed by CONTRACTOR pursuant hereto has been completed and accepted by COUNTY and damages suffered by COUNTY, if any, ascertained. Damages shall include by way of illustration, but not of exclusion, COUNTY's costs of completing the Work which exceeds the compensation payable pursuant to this Agreement, other general, liquidated, special or consequential damages, attorney fees and costs.

16.3. Actions After Default. Should COUNTY exercise any of its options, remedies or rights granted pursuant to the terms of this Agreement in the event of a default by CONTRACTOR, COUNTY at its sole election may, but shall not be obligated to, use any materials, supplies, tools or equipment on the work site which belong to CONTRACTOR to complete the Work required to be completed by CONTRACTOR, whether such work is completed by COUNTY or by others, and CONTRACTOR agrees that it shall not remove such materials, supplies, tools and equipment from the work site unless directed in writing by COUNTY to do so.

16.4. Limit on Force Majeure Damages. CONTRACTOR shall not be responsible for repairing or restoring damage to work caused by an act of God in excess of five (5) percent of the contract amount, provided that the work damaged is built in accordance with accepted and applicable building standards and the plans and specifications of COUNTY. In the event of such damage, COUNTY may, at its option, elect to terminate this Agreement. For purposes of this Agreement, an "act of God" shall be defined as an earthquake in excess of 3.5 on the Richter Scale and a tidal wave.

16.5. Resolution of Claims. COUNTY and CONTRACTOR agree to follow and comply with

1 the mediation, arbitration, claim, civil action procedure and trial de novo provisions set
2 forth in California Public Contracts Code §§ 9204 and 20104 – 20104.6.

3 **16.6. No Limitation of Rights.** The options and rights granted to COUNTY herein shall not be
4 deemed as limitations upon the other rights and remedies of COUNTY in the event of a
5 failure of performance or breach by CONTRACTOR, and COUNTY shall be entitled to
6 exercise the rights and remedies hereinabove specified and all other rights and remedies
7 which may be provided in this Agreement or by law or in equity, either cumulatively or
8 consecutively, and in such order as COUNTY in its sole discretion shall determine.

9 **17. NON-DISCRIMINATION.**

10 **17.1.** During the performance of this Agreement, CONTRACTOR and its subcontractors shall
11 not unlawfully discriminate, harass or allow harassment against any employee or
12 applicant for employment because of sex, race, color, ancestry, religious creed, national
13 origin, physical disability (including HIV and AIDS), mental disability, medical
14 condition (cancer), age (over forty (40)), marital status and denial of family care leave.

15 **17.2.** CONTRACTOR and its subcontractors shall insure that the evaluation and treatment of
16 their employees and applicants for employment are free from such discrimination and
17 harassment.

18 **17.3.** CONTRACTOR and its subcontractors shall comply with the provisions of the Fair
19 Employment and Housing Act (Gov. Code §12990 (a-f) et seq.) and the applicable
20 regulations promulgated thereunder (California Code of Regulations, Title 2, Section
21 7285 et seq.).

22 **17.4.** The applicable regulations of the Fair Employment and Housing Commission
23 implementing Government Code §12990 (a-f), set forth in Chapter 5 of Division 4 of
24 Title 2 of the California Code of Regulations, are incorporated into this Agreement by
25 reference and made a part hereof as if set forth in full.

26 **17.5.** The applicable regulations of Section 504 of the Rehabilitation Act of 1973 (29 U.S.C.
27 §794 (a)) are incorporated into this Agreement by reference and made a part hereof as if
28 set forth in full.

- 1 **17.6.** CONTRACTOR and its subcontractors shall give written notice of their obligations under
2 this clause to labor organizations with which they have a collective bargaining or other
3 agreement.
- 4 **17.7.** CONTRACTOR shall include the nondiscrimination and compliance provisions of this
5 clause in all subcontracts to perform Work under this Agreement.
- 6 **18. DISADVANTAGED BUSINESS ENTITY COMPLIANCE.**
- 7 **18.1.** When applicable, CONTRACTOR and its subcontractors shall reference and abide by
8 the guidance and Disadvantaged Business Enterprise (“DBE”) specifications contained
9 in the California Department of Transportation’s Standard Specifications.
- 10 **18.2.** CONTRACTOR represents and warrants that is has fully read the applicable DBE
11 requirements pertaining to this Project and has fully and accurately completed any and
12 all required DBE forms.
- 13 **18.3.** CONTRACTOR represents and warrants that it will comply with all applicable DBE
14 requirements for this Project.
- 15 **18.4.** CONTRACTOR shall comply with the applicable DBE provisions attached hereto as
16 **Exhibit “D”** and incorporated by this reference as though fully set forth herein.
- 17 **18.5.** If any state or federal funds are withheld from COUNTY or not reimbursed to COUNTY
18 due to CONTRACTOR’s failure to either comply with the DBE requirements set forth in
19 the RFP and this Agreement, or to meet the mandatory DBE goals as determined by
20 COUNTY, Caltrans, the Federal Highway Administration, and/or any other state or
21 federal agency contributing funds to the Project, then CONTRACTOR shall fully
22 reimburse COUNTY the amount of funding lost. COUNTY reserves the right to deduct
23 any such loss in funding from the amount of compensation due to CONTRACTOR under
24 this Agreement.
- 25 **18.6.** In addition to the above, CONTRACTOR’s failure to comply with DBE
26 requirements/goals shall subject it to such sanctions as are permitted by law, which may
27 include, but shall not be limited to the following:
- 28 **18.6.1.** Termination of this Agreement;

1 **18.6.2.** Withholding monthly progress payments;

2 **18.6.3.** Denial of payment for any portion of the Project that was committed at the time
3 of the execution of this Agreement to be performed by a DBE subcontractor, but
4 was completed by CONTRACTOR or a substitute non-DBE subcontractor;

5 **18.6.4.** Compensatory, special, incidental, liquidated and other damages; and/or

6 **18.6.5.** Designation of CONTRACTOR as “nonresponsible,” and disqualification from
7 bidding on future public works projects advertised by COUNTY.

8 **19. PREVAILING WAGE.**

9 **19.1.** CONTRACTOR and its subcontractors shall pay all workers employed on the Project the
10 higher of either the rates determined by the Director of the California Department of
11 Industrial Relations (“DIR”) or, when applicable, the Davis-Bacon Federal wage rates as
12 supplemented by the Department of Labor regulations. The Davis-Bacon Federal wage
13 rates are attached to the RFP. Copies of the State prevailing rate of per diem wages are
14 on file with the Department of Industrial Relations, Division of Apprenticeship Standards,
15 445 Golden Gate Avenue, San Francisco, California, and at COUNTY’s Department of
16 Public Works, and are available to CONTRACTOR and any other interested party upon
17 request. CONTRACTOR shall post the prevailing rate of per diem wages to be posted at
18 the Project site.

19 **19.2.** CONTRACTOR is aware of Labor Code Sections 1720 et seq. and 1770 et seq., as well
20 as California Code of Regulations, Title 8 , Section 16000 et seq. (“Prevailing Wage
21 Law”), which require the payment of prevailing wage rates and the performance of other
22 requirements on certain “public works” projects, including work done for irrigation,
23 utility, reclamation, and improvement districts, and other districts of this type. The Work
24 on the Project involves “public works”, as defined by the Prevailing Wage Laws, and the
25 total compensation is \$1,000 (one thousand) dollars or more. Contractor therefore agrees
26 to fully comply with such Prevailing Wage Laws. To the extent required under the Civil
27 Code or any other provision of law, Contractor shall deliver bonds to secure the payment
28 of its workers and subcontractors, including the payment of wages to works performing

the work identified in Labor Code section 1720(a)(2).

19.3. CONTRACTOR is responsible for compliance with the provisions herein.

19.4. Mandatory Registration with the Department of Industrial Relations – NEW REQUIREMENTS PURSUANT TO SB 854.

19.4.1. CONTRACTOR and its subcontractors shall register with the DIR and pay all applicable fees as set forth in Labor Code section 1725.5.

19.4.2. CONTRACTOR and its subcontractors acknowledge that they shall not be listed on any bid proposal for a public works project (submitted on or after March 1, 2015) unless registered with the DIR pursuant to Labor Code section 1725.5. The requirements of this section shall apply unless one of the limited exceptions provided under Labor Code Section 1771.1(a) applies.

19.4.3. CONTRACTOR and its subcontractors acknowledge that they shall not be awarded any contract for public work on a public works project (awarded on or after April 1, 2015) unless registered with the DIR pursuant to Labor Code section 1725.5.

19.4.4. The Project described herein is subject to compliance monitoring and enforcement with the DIR.

19.4.5. For further information concerning compliance with SB 854, please visit: <http://www.dir.ca.gov/Public-Works/SB854.html>.

19.5. Cognizance of Violations by County.

19.5.1. CONTRACTOR understands and agrees that COUNTY shall take cognizance of violations of Chapter 1 of Part 7 of Division 2 of the California Labor Code committed in the course of the execution of this Agreement, and shall promptly report any suspected violations to the Labor Commissioner.

19.5.2. If CONTRACTOR determines as a result of its own investigation that there has been a violation of Chapter 1 of Part 7 of Division 2 of the California Labor Code and withholds payment to CONTRACTOR, the procedures in California Labor Code §1771.6 shall be followed.

1 **19.5.3.** CONTRACTOR may bring an action in a court of competent jurisdiction to
2 recover from COUNTY the difference between the wages actually paid to an
3 employee and the wages that were required to be paid to an employee pursuant to
4 Chapter 1 of Part 7 of Division 2 of the California Labor Code, any penalties
5 required to be paid pursuant to Chapter 1 of Part 7 of Division 2 of the California
6 Labor Code, and costs and attorney's fees related to the action, if either of the
7 following is true:

8 **(a)** COUNTY previously affirmatively represented to CONTRACTOR in
9 writing, in the call for bids, or otherwise, that the Work was not a "public
10 work," as defined in Chapter 1 of Part 7 of Division 2 of the California
11 Labor Code; or

12 **(b)** COUNTY received actual written notice from the Department of
13 Industrial Relations that the Work is a "public work," as defined in
14 Chapter 1 of Part 7 of Division 2 of the California Labor Code, and failed
15 to disclose that information to CONTRACTOR before the bid opening or
16 award.

17 **19.6. Prevailing Wage Rates and Payroll Records.**

18 **19.6.1.** CONTRACTOR agrees to comply with §§1775 and 1776 of the California Labor
19 Code relating to the payment of prevailing wage and the maintenance of certified
20 payroll records and to make the certified payroll records available for inspection
21 at all reasonable hours at CONTRACTOR's principal office. The responsibility
22 for compliance with these provisions is fixed with CONTRACTOR.
23 CONTRACTOR understands and agrees that it shall, as a penalty to COUNTY,
24 forfeit specific monetary fines for each worker paid less than the prevailing wage
25 rates as determined by the Labor Commissioner for the work or craft in which the
26 worker is employed for any Work done pursuant to this Agreement.

27 **19.6.2.** *Prevailing Wage Compliance For those Projects subject to DIR Monitoring and*
28 *Enforcement.* CONTRACTOR has reviewed and agrees to comply with any

1 applicable provisions for those Projects subject to Department of Industrial
2 Relations (DIR) Monitoring and Enforcement of prevailing wages. COUNTY
3 hereby notifies CONTRACTOR that CONTRACTOR is responsible for
4 complying with the requirements of Senate Bill 854 (SB854) regarding certified
5 payroll record reporting. Further information concerning the requirements of
6 SB854 is available on the DIR website located at: [http://www.dir.ca.gov/Public-
7 Works/PublicWorksEnforcement.html](http://www.dir.ca.gov/Public-Works/PublicWorksEnforcement.html).

8 **19.6.3.** CONTRACTOR shall be liable for penalties pursuant to this section when a
9 subcontractor on the Project fails to pay its workers the general prevailing rate of
10 per diem wages and any of the following conditions are met:

- 11 (a) CONTRACTOR had knowledge of that failure of the subcontractor to pay
12 the specified prevailing rate of wages to those workers; or
- 13 (b) CONTRACTOR fails to comply with the following requirement: The
14 contract executed between CONTRACTOR and the subcontractor for the
15 performance of Work on the Project shall include a copy of the provisions
16 of California Labor Code §§1771, 1775, 1776, 1777.5, 1813 and 1815;
17 and
- 18 (c) CONTRACTOR fails to comply with the following requirement:
19 CONTRACTOR shall monitor the payment of the specified general
20 prevailing rate of per diem wages by the subcontractor to the employees,
21 by periodic review of the certified payroll records of the subcontractor;
22 and
- 23 (d) Upon becoming aware of the failure of the subcontractor to pay his or her
24 workers the specified prevailing rate of wages, CONTRACTOR shall
25 diligently take corrective action to halt or rectify the failure, including, but
26 not limited to, retaining sufficient funds due the subcontractor for work
27 performed on the public works project; and
- 28 (e) Prior to making final payment to the subcontractor for Work performed

1 on the Project, CONTRACTOR shall obtain an affidavit signed under
2 penalty of perjury from the subcontractor that the subcontractor has paid
3 the specified general prevailing rate of per diem wages to his or her
4 employees on the Project and any amounts due pursuant to California
5 Labor Code §1813.

6 **19.7. Work Day and Work Week Requirements.** CONTRACTOR agrees to comply with
7 §§1810 through 1815 of the California Labor Code and, when applicable, sections 103
8 and 107 of the Contract Work Hours and Safety Standards Act, 40 U.S.C. §§3700 et seq.,
9 as supplemented by the Department of Labor regulations, which provide that
10 CONTRACTOR's workers and its subcontractor's workers may not be required or
11 permitted to work more than eight (8) hours in any one (1) calendar day and forty (40)
12 hours in any one (1) calendar week. Further, work performed by employees of
13 CONTRACTOR or its subcontractor in excess of eight (8) hours per day, and forty (40)
14 hours during any one (1) week, shall be compensated for all hours worked in excess of
15 eight (8) hours per day at not less than one and one-half (1½) times the basic rate of pay.
16 The responsibility for compliance with these provisions is fixed with CONTRACTOR.
17 CONTRACTOR understands and agrees that it shall, as a penalty to COUNTY, forfeit
18 specific monetary fines to COUNTY should CONTRACTOR or its subcontractors fail to
19 comply with the provisions contained within this Paragraph.

20 **19.8. Apprenticeship Requirements.**

21 **19.8.1.** CONTRACTOR agrees to comply with §§1777.5, 1777.6 and 1777.7 of the
22 California Labor Code relating to the employment of apprentices and to provide
23 COUNTY with copies of any contract award information and verified statements
24 of the journeyman and apprentice hours performed pursuant to this Agreement as
25 required by §1777.5(e). The responsibility for compliance with these provisions
26 is fixed with CONTRACTOR for all apprenticeable occupations, where
27 journeymen in the craft are employed on the public work, in a ratio of not less
28 than one (1) apprentice for each five (5) journeymen (unless an exemption is

1 granted in accordance with §1777.5) and CONTRACTOR and its subcontractors
2 shall not discriminate among otherwise qualified employees as indentured
3 apprentices on any public work solely on the ground of race, religious creed, color,
4 national origin, ancestry, sex, or age, except as provided in California Labor Code
5 §3077. Only apprentices, as defined in California Labor Code §3077, who are in
6 training under apprenticeship standards and who have signed written apprentice
7 agreements will be employed on public works in apprenticeable occupations.
8 This section shall not be enforced if the not-to-exceed amount of this Agreement
9 set forth and/or incorporated in the "COMPENSATION" Section is less than
10 thirty thousand dollars (\$30,000).

11 **19.8.2.** If the Project falls within the jurisdiction of California Labor Code §1777.5,
12 COUNTY shall, within five (5) days of the award, send a copy of the award to the
13 Division of Apprenticeship Standards. In addition, COUNTY shall notify the
14 Division of Apprenticeship Standards of a finding of any discrepancy regarding
15 the ratio of apprentices to journeymen within five (5) days of the finding.

16 **19.9. Labor Standards Compliance Requirements.**

17 **19.9.1.** It is CONTRACTOR's responsibility to provide all labor compliance
18 documentation from its subcontractors completely and accurately in a timely
19 manner. CONTRACTOR is responsible to review promptly and then forward on
20 all required documentation to COUNTY per the time schedules in the Labor
21 Compliance Handout. Included with the Labor Compliance Handout, COUNTY
22 will provide training, documentation requirements, forms, etc., at the
23 preconstruction conference or at a time designated by COUNTY.

24 **19.9.2.** In the event, during the review process of labor compliance documentation from
25 COUNTY's labor compliance monitor, inaccurate, missing or incomplete
26 information was provided, the labor compliance monitor will request from
27 CONTRACTOR the items, revisions and documentation needed. The cost of this
28 additional labor compliance enforcement shall be borne by CONTRACTOR.

1 **20. INELIGIBILITY.**

2 **20.1.** CONTRACTOR represents and warrants that it and its subcontractors are not ineligible
3 to work for COUNTY due to violations of Labor Code §§1777.1 and 1777.7.

4 **20.2.** If CONTRACTOR is deemed ineligible to perform work on public works projects
5 pursuant to Labor Code Sections 1777.1 or 1777.7, then CONTRACTOR shall be
6 prohibited from bidding on, being awarded an agreement for, or performing work as a
7 subcontractor on this Project, or any other public works project within the state of
8 California.

9 **21. SIGNAGE REQUIREMENTS.**

10 **21.1. Project Identity Signage.** CONTRACTOR is required to provide and install the required
11 project identity signage as detailed in the Plans and Specifications, in the size and at the
12 location indicated by the Director of Public Works or his/her designee, and to maintain
13 the signage in good condition for the duration of the Project. The signage may not be
14 removed until the Notice of Completion is recorded or by written direction of the Director
15 of Public Works or his/her designee.

16 **21.2. Required Employee Signage and Posters.** CONTRACTOR is required to provide and
17 install the Federal and State required employee posters and the required material
18 pertaining to the required labor standards provisions are posted (including, but not limited
19 to, WH-1321, OSHA 3165 and OFCCP-English, EFCCP-Spanish) at the worksite in a
20 prominent and accessible place.

21 **21.3. Section 3 Compliant Signage.** If required by COUNTY, CONTRACTOR is directed to
22 provide and install the "Offer for Employment" signage as detailed in the Plans and
23 Specifications in the size and at the location indicated by the Director of Public Works or
24 his/her designee and to maintain the signage in good condition for the duration of the
25 Project. The signage may not be removed until the Notice of Completion is recorded or
26 by written direction of the Director of Public Works or his/her designee.

27 **22. CONFLICT OF INTEREST AND GRATUITIES.**

28 **22.1.** CONTRACTOR agrees that it presently has no interest and shall not acquire any interest,

1 direct or indirect, which could conflict in any manner or degree with the performance of
2 services required to be performed under this Agreement. CONTRACTOR further agrees
3 that in the performance of this Agreement, no person having any such interest shall be
4 employed.

5 **22.2.** CONTRACTOR agrees to designate such person or persons who have responsibility for
6 carrying out the services under this Agreement and that such person or persons as may be
7 designated shall take any and all actions necessary to comply with COUNTY's Conflict
8 of Interest Code adopted pursuant to California Government Code §81000 to the extent
9 required thereunder.

10 **22.3.** If it is found, after notice and hearing by COUNTY, that gratuities (in the form of
11 entertainment., gifts, or otherwise) were offered or given by CONTRACTOR, or any
12 agent or representative of CONTRACTOR, to any officer, employee or agent of
13 COUNTY with a view toward securing a contract or securing favorable treatment with
14 respect to the awarding or amending or the making of any determinations with respect to
15 the performance of this Agreement, COUNTY may, by written notice to
16 CONTRACTOR, terminate the right of CONTRACTOR to proceed under this
17 Agreement and/or may pursue such other rights and remedies provided by law or under
18 this Agreement.

19 **22.4.** In the event this Agreement is terminated as provided herein, COUNTY shall be entitled
20 to:

21 **22.4.1.** Pursue the same remedies against CONTRACTOR as it could pursue in the event
22 of a breach of the Agreement by CONTRACTOR; and

23 **22.4.2.** As a penalty in addition to any other damages to which it may be entitled by law,
24 to exemplary damages in an amount (as determined by COUNTY) which shall be
25 not less than three (3) nor more than ten (10) times the costs incurred by
26 CONTRACTOR in providing any such gratuities to any such officer, employee
27 or agent.

28 **23. HOUSING AND URBAN DEVELOPMENT ACT COMPLIANCE.**

1 When applicable, CONTRACTOR agrees to comply with Section 3 of the Housing and Urban
2 Development Act of 1968 (42 U.S.C. 3601 et seq.) which provides that to the greatest extent feasible,
3 CONTRACTOR shall provide job training, employment and contracting opportunities for low- or very-
4 low income residents in connection with the Project. The responsibility for compliance with these
5 provisions is fixed with CONTRACTOR.

6 **24. COPELAND "ANTI-KICKBACK" ACT COMPLIANCE.**

7 When applicable, CONTRACTOR agrees to comply with the Copeland Act
8 (*18 USC §874 and 40 USC §276c; 29 C.F.R. Part 3*) which precludes CONTRACTOR and its
9 subcontractors from in any way inducing an employee to give up any part of the compensation to which
10 he or she is entitled under his or her contract of employment. CONTRACTOR and its subcontractors
11 shall submit a weekly statement of the wages paid to each employee performing on covered work during
12 the preceding payroll period. CONTRACTOR understands and agrees that should CONTRACTOR its
13 subcontractors induce an employee working on a covered contract to give up any part of the
14 compensation to which he or she is entitled, the inducing party may be subject to a five thousand dollar
15 (\$5,000) fine, or imprisonment for up to five (5) years, or both. CONTRACTOR also understands and
16 agrees that willful falsification of the statement of compliance may subject the employer to civil or
17 criminal prosecution and may be cause for contract termination or debarment. The responsibility for
18 compliance with these provisions is fixed with CONTRACTOR.

19 **25. FAIR LABOR STANDARDS ACT COMPLIANCE.**

20 When applicable, CONTRACTOR agrees to comply with the Fair Labor Standards Act of 1938
21 as amended (29 U.S.C. 201 et seq.) which establishes minimum wage, overtime pay, recordkeeping, and
22 youth employment standards affecting full-time and part-time workers on the Project. The responsibility
23 for compliance with these provisions is fixed with CONTRACTOR.

24 **26. CERTIFICATION REGARDING DEBARMENT, SUSPENSION AND OTHER**
25 **RESPONSIBILITY MATTERS.**

26 When applicable, CONTRACTOR agrees to execute a certification regarding debarment,
27 suspension and other responsibility matters. The responsibility for compliance with this provision is
28 fixed with CONTRACTOR.

1 **27. FEDERAL EQUAL EMPLOYMENT OPPORTUNITY CONSTRUCTION CONTRACT**
2 **SPECIFICATIONS.**

3 When applicable, CONTRACTOR agrees to incorporate the notice set forth in paragraph (d) of
4 41 C.F.R. 60-4.2 relating to the "Equal Opportunity Clause" and the "Standard Federal Equal
5 Employment Specifications." The responsibility for compliance with this provision is fixed with
6 CONTRACTOR.

7 **28. CLEAN AIR ACT AND THE FEDERAL WATER POLLUTION CONTROL ACT.**

8 When applicable, CONTRACTOR agrees to comply with all applicable standards, orders or
9 regulations issued pursuant to the Clean Air Act (42 U.S.C. 7401 et seq.), the Federal Water Pollution
10 Control Act as amended (33 U.S.C. 1251 et seq.), Presidential Executive Order 11738 and
11 Environmental Protection Agency regulations set forth at 40 C.F.R. Part 15. CONTRACTOR
12 understands and agrees that violations shall be reported to the Federal awarding agency and the Regional
13 Office of the Environmental Protection Agency. The responsibility for compliance with these provisions
14 is fixed with CONTRACTOR.

15 **29. PROHIBITION ON THE USE OF FEDERAL FUNDS FOR LOBBYING.**

16 When applicable, CONTRACTOR shall file the required certification. Each tier certifies to the
17 tier above that it will not and has not used Federal appropriated funds to pay any person or organization
18 for influencing or attempting to influence an officer or employee of any agency, a member of Congress,
19 officer or employee of Congress, or an employee of a member of Congress in connection with obtaining
20 any Federal contract, grant or any other award covered by 31 U.S.C. 1352. Each tier shall also disclose
21 any lobbying with non-Federal funds that takes place in connection with obtaining any Federal award.
22 Such disclosures are forwarded from tier to tier up to the recipient. The responsibility for compliance
23 with this provision is fixed with CONTRACTOR.

24 **30. FEDERAL EMPLOYMENT ELIGIBILITY VERIFICATION.**

25 CONTRACTOR shall verify name, date of birth and social security number, along with
26 immigration information for non-citizens in order to verify the identity and employment eligibility of
27 both citizen and non-citizen new hires. The responsibility for compliance with this provision is fixed
28 with CONTRACTOR.

1 **31. THE CIVIL RIGHTS, HCD AND AGE DISCRIMINATION ACT ASSURANCES.**

2 **31.1.** During the performance of this Agreement, CONTRACTOR assures that no otherwise
3 qualified person shall be excluded from participation or employment, denied program
4 benefits or be subjected to discrimination based on race, color, national origin, gender,
5 age or handicap, under any program or activity funded by this Agreement, as required by
6 Title VI of the Civil Rights Act of 1964, Title I of the Housing and Community
7 Development Act of 1974, as amended, and the Age Discrimination Act of 1975, and all
8 implementing regulations. The responsibility for compliance with these provisions is
9 fixed with CONTRACTOR.

10 **31.2.** CONTRACTOR and its subcontractors shall not discriminate on the basis of race, color,
11 national origin, or sex in the performance of this Agreement. CONTRACTOR shall carry
12 out the applicable requirements of 49 C.F.R. Chapter 26 in the award and administration
13 of Department of Transportation assisted contracts. Failure by CONTRACTOR to carry
14 out these requirements is a material breach of this Agreement, which may result in the
15 termination of this Agreement, or such other remedy as COUNTY deems appropriate.
16 CONTRACTOR shall include the nondiscrimination and compliance provisions of this
17 Paragraph in all subcontracts to perform Work under this Agreement.

18 **32. FEDERAL EQUAL EMPLOYMENT OPPORTUNITY REQUIREMENTS.**

19 **32.1.** CONTRACTOR hereby agrees that it will incorporate or cause to be incorporated into
20 any contract for construction work, or modification thereof, as defined in the regulations
21 of the Secretary of Labor at 41 C.F.R. Chapter 60, which is paid for in whole or in part
22 with funds obtained from the Federal Government or borrowed on the credit of the
23 Federal Government pursuant to a grant, contract, loan insurance, or guarantee, or
24 undertaken pursuant to any Federal program involving such grant, contract, loan,
25 insurance, or guarantee, the following equal opportunity clause. For the purposes of this
26 Subsection, the term "contractor" shall refer to CONTRACTOR, and the term "contract"
27 shall refer to this Agreement:

28 *"During the performance of this contract, the Contractor agrees as follows:*

- 1 (1) *The contractor will not discriminate against any employee or applicant for*
2 *employment because of race, color, religion, sex, or national origin. The*
3 *contractor will take affirmative action to ensure that applicants are*
4 *employed, and that employees are treated during employment, without*

6 *shall include, but not be limited to the following: Employment, upgrading,*

9 *training, including apprenticeship. The contractor agrees to post in*
10 *conspicuous places, available to employees and applicants for employment,*
11 *notices to be provided by the contracting officer setting forth the provisions*
12 *of this nondiscrimination clause.*
- 13 (2) *The contractor will, in all solicitations or advertisements for employees*
14 *placed by or on behalf of the contractor, state that all qualified applicants*
15 *will receive consideration for employment without regard to race, color,*
16 *religion, sex, or national origin.*
- 17 (3) *The contractor will send to each labor union or representative of workers*
18 *with which he has a collective bargaining agreement or other contract or*
19 *understanding, a notice to be provided by the agency contracting officer,*
20 *advising the labor union or workers' representative of the contractor's*
21 *commitments under section 202 of Executive Order 11246 of September 24,*
22 *1965, and shall post copies of the notice in conspicuous places available to*
23 *employees and applicants for employment.*
- 24 (4) *The contractor will comply with all provisions of Executive Order 11246 of*
25 *September 24, 1965, and of the rules, regulations, and relevant orders of*
26 *the Secretary of Labor.*
- 27 (5) *The contractor will furnish all information and reports required by*
28 *Executive Order 11246 of September 24, 1965, and by the rules,*

1 regulations, and orders of the Secretary of Labor, or pursuant thereto, and
2 will permit access to his books, records, and accounts by the contracting
3 agency and the Secretary of Labor for purposes of investigation to ascertain
4 compliance with such rules, regulations, and orders.

5 (6) In the event of the contractor's non-compliance with the nondiscrimination
6 clauses of this contract or with any of such rules, regulations, or orders,
7 this contract may be canceled, terminated or suspended in whole or in part
8 and the contractor may be declared ineligible for further Government
9 contracts in accordance with procedures authorized in Executive Order
10 11246 of September 24, 1965, and such other sanctions may be imposed
11 and remedies invoked as provided in Executive Order 11246 of September
12 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as
13 otherwise provided by law.

14 (7) the contractor will include the provisions of paragraphs (1) through (7) in
15 every subcontract or purchase order unless exempted by rules, regulations,
16 or orders of the Secretary of Labor issued pursuant to section 204 of
17 Executive Order 11246 of September 24, 1965, so that such provisions will
18 be binding upon each subcontractor or vendor. The contractor will take
19 such action with respect to any subcontract or purchase order as may be
20 directed by the Secretary of Labor as a means of enforcing such provisions
21 including sanctions for noncompliance: Provided, however, that in the
22 event the contractor becomes involved in, or is threatened with, litigation
23 with a subcontractor or vendor as a result of such direction, the contractor
24 may request the United States to enter into such litigation to protect the
25 interests of the United States."

26 **32.2.** CONTRACTOR further agrees that it will be bound by the above equal opportunity
27 clause with respect to its own employment practices when it participates in federally-
28 assisted construction work; provided that if CONTRACTOR so participating is a State or

1 local government, the above equal opportunity clause is not applicable to any agency,
2 instrumentality, or subdivision of such government which does not participate in work on
3 or under the Agreement.

4 **32.3.** CONTRACTOR agrees that it will assist and cooperate actively with the administering
5 agency and the Secretary of Labor in obtaining the compliance of Contractors and
6 subcontractors with the equal opportunity clause and the rules, regulations, and relevant
7 orders of the Secretary of Labor, that it will furnish the Department and HUD and the
8 Secretary of Labor such information as they may require for the supervision of such
9 compliance, and that it will otherwise assist the administering agency in the discharge of
10 the agency's primary responsibility for securing compliance.

11 **32.4.** CONTRACTOR further agrees that it will refrain from entering into any contract or
12 contract modification subject to Executive Order 11246 of September 24, 1965, with a
13 contractor debarred from, or who has not demonstrated eligibility for, government
14 contracts and federally-assisted construction contracts, pursuant to the Executive Order
15 and will carry out such sanctions and penalties for violation of the equal opportunity
16 clause as may be imposed upon contractors and subcontractors by the administering
17 agency or the Secretary of Labor pursuant to Part II, Subpart D of the Executive Order.
18 In addition, CONTRACTOR agrees that if it fails or refuses to comply with these
19 undertakings, COUNTY may take any or all of the following actions: Cancel, terminate,
20 or suspend in whole or in part this funding commitment (contract, loan, grant, insurance,
21 guarantee); refrain from extending any further assistance to the applicant under the
22 program with respect to which the failure or refund occurred until satisfactory assurance
23 of future compliance has been received from such Contractor; and refer the case to the
24 Department of Justice for appropriate legal proceedings.

25 **33. ASSIGNMENT OF CLAIMS – CLAYTON OR CARTWRIGHT ACTS.**

26 CONTRACTOR shall comply with the following provisions regarding the assignment of claims
27 arising from either the Clayton Act or the Cartwright. For the purposes of this Section, the term
28 "contractor" shall refer to CONTRACTOR, the term "awarding body" shall refer to COUNTY, and the

term "public works contract" shall refer to this Agreement:

"In entering into a public works contract or a subcontract to supply goods, services, or materials pursuant to a public works contract, the contractor or subcontractor offers and agrees to assign to the awarding body all rights, title, and interest in and to all causes of action it may have under Section 4 of the Clayton Act (15 U.S.C. Sec. 15) or under the Cartwright Act (Chapter 2 (commencing with Section 16700) of Part 2 of Division 7 of the Business and Professions Code), arising from purchases of goods, services, or materials pursuant to the public works contract or the subcontract. This assignment shall be made and become effective at the time the awarding body tenders final payment to the contractor, without further acknowledgment by the parties."

34. NON-COLLUSION.

CONTRACTOR agrees he/she has executed and submitted with the Bid a Non-Collusion Affidavit that complies with Cal. Public Code §7106, included in **Exhibit "B"** and incorporated herein.

35. NOTICES AND REPORTS.

4 given when deposited in the United States Mail, postage prepaid, addressed as provided
5 herein.

6 **36. ENTIRE AGREEMENT.**

7 This Agreement contains the entire agreement between COUNTY and CONTRACTOR relating
8 to the transactions contemplated hereby and supersedes all prior or contemporaneous agreements,
9 understandings, provisions, negotiations, representations, or statements, either written or verbal.

10 **37. ASSIGNMENT.**

11 Neither this Agreement nor any duties or obligations hereunder shall be assignable by
12 CONTRACTOR without the prior written consent of COUNTY.

13 **38. MODIFICATION.**

14 No modification, waiver, amendment, discharge, or change of this Agreement shall be valid
15 unless the same is in writing and signed by the Party against whom the enforcement of such modification,
16 waiver, amendment, discharge, or change is or may be sought.

17 **39. CAPTIONS.**

18 Captions in this Agreement are inserted for convenience of reference only and do not define,
19 describe or limit the scope or the intent of this Agreement or any of the terms thereof.

20 **40. PARTIAL INVALIDITY.**

21 If any provision in this Agreement is held by a court of competent jurisdiction to be invalid, void,
22 or unenforceable, the remaining provisions will nevertheless continue in full force without being
23 impaired or invalidated in any way.

24 **41. GENDER AND INTERPRETATION OF TERMS AND PROVISIONS.**

25 Words and expressions in the masculine gender include the feminine and neuter genders. Words
26 and expressions in the singular include the plural and words and expressions in the plural include the
27 singular. CONTRACTOR as used in this Agreement or in any other document referred to in or made a
28 part of this Agreement shall likewise include both singular and the plural, a corporation, a partnership,

1 individual, firm or person acting in any fiduciary capacity as executor, administrator, trustee or in any
2 other representative capacity or any other entity. All covenants herein contained on the part of
3 CONTRACTOR shall be joint and several if more than one person, firm or entity executes the
4 Agreement.

5 **42. WAIVER.**

6 No waiver of any breach or of any of the covenants or conditions of this Agreement shall be
7 construed to be a waiver of any other breach or to be consent to any further or succeeding breach of the
8 same or any other covenant or condition.

9 **43. CHOICE OF LAW.**

10 The laws of the State of California shall govern this Agreement. This Agreement is made and
11 entered into in Imperial County, California. Any action brought by either Party with respect to this
12 Agreement shall be brought in a court of competent jurisdiction within said County.

13 **44. AUTHORITY.**

14 **44.1.** Each individual executing this Agreement on behalf of CONTRACTOR represents and
15 warrants that:

16 **44.1.1.** He/She is duly authorized to execute and deliver this Agreement on behalf of
17 CONTRACTOR;

18 **44.1.2.** Such execution and delivery is in accordance with the terms of the Articles of
19 Incorporation or Partnership, any by-laws or Resolutions of CONTRACTOR and;

20 **44.1.3.** This Agreement is binding upon CONTRACTOR in accordance with its terms.

21 **44.2.** CONTRACTOR shall deliver to COUNTY evidence acceptable to COUNTY of the
22 foregoing within thirty days of execution of this Agreement.

23 **45. COUNTERPARTS.**

24 This Agreement and any subsequent modifications may be executed in any number of
25 counterparts, each of which when executed shall be an original, and all of which together shall constitute
26 one and the same Agreement. No counterparts shall be effective until all Parties have executed a
27 counterpart hereof.

28 **46. TIMING.**

1 The Parties agree that time is of the essence in this Agreement.

2 **47. REVIEW OF AGREEMENT TERMS.**

3 **47.1.** Each Party has had the opportunity to receive independent legal advice from its attorneys
4 with respect to the advisability of making the representations, warranties, covenants and
5 agreements provided for herein, and with respect to the advisability of executing this
6 Agreement.

7 **47.2.** Each Party represents and warrants to and covenants with the other Party that:

8 **47.2.1.** This Agreement in its reduction to final written form is a result of extensive good
9 faith negotiations between the Parties and/or their respective legal counsel; and

10 **47.2.2.** The Parties and/or their legal counsel have carefully reviewed and examined this
11 Agreement for execution by said Parties.

12 **47.3.** Any statute or rule of construction that ambiguities are to be resolved against the drafting
13 party shall not be employed in the interpretation of this Agreement.
