#### ADDENDUM NO. 1

**January 14, 2026**

This **ADDENDUM** is hereby made part of the Contract Documents and specifications to the same extent as if originally included therein, and shall be signed by the Bidder and included with the proposal.

***Question 1: Is the County looking for a turn-key team that can provide all associated services to support the potential project types in the RFP scope of work such as environmental, geotechnical, electrical, etc.? Or is the County's intent to utilize/assemble the selected consultants from the other on-call, as needed RFP's to build a comprehensive team for projects?***

Answer: The County is not requiring proposers to submit a turn-key team for all associated disciplines. Depending on the needs of each individual task order, the County may utilize its own on-call consultants and/or allow the selected civil engineering consultant to propose subconsultants with prior County approval, in accordance with the RFP. The approach will be determined by the County on a task-by-task basis.

***Question 2. Can a proposer be the Prime and Sub on the same opportunity?***


Answer: No. A firm may only participate in a task order in a single role. A consultant may not serve as both the prime consultant and a subconsultant on the same task order.

***Question 3. Will the County be selecting firms from various on-call contracts to service task orders? Or will the prime consultant be expected to have a team of subconsultants under the on-call?***

Answer: The County may select firms from various on-call contracts to support a task order, and/or may allow the prime consultant to propose subconsultants with prior County approval. The County will determine the most appropriate delivery approach based on the needs of each specific task order.

***Item 1:*** Please be advised that the deadline for submission is extended from Monday, January 19, 2026 to Tuesday, January 27, 2026, for all methods of submittal.

***Item 2:*** Please be advised that the County has added a separate PlanetBids upload link labeled "Cost Proposal". Proposers shall submit the Technical Proposal under the main upload and the cost proposal under the "Cost Proposal" upload link.
